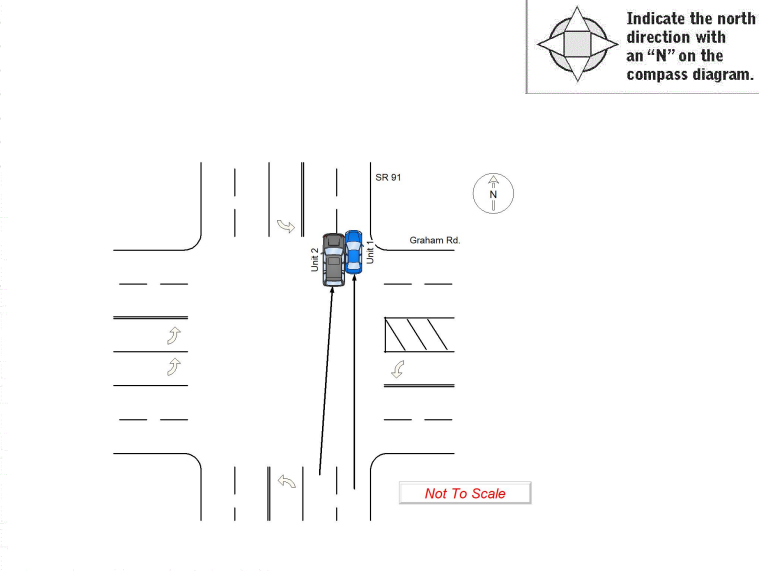

Unit 1 was facing northbound on SR 91 at Graham Rd., in the curbside lane. Unit 2 was facing northbound on SR 91 at Graham Rd., in the inside lane. Both units were stopped at the red light. When the light turned green, both units accelerated. Unit 1 maintained its lane through the intersection. Unit 2 drifted into Unit 1's lane, sideswiping the vehicle. Unit 2 then continued northbound, leaving the scene.

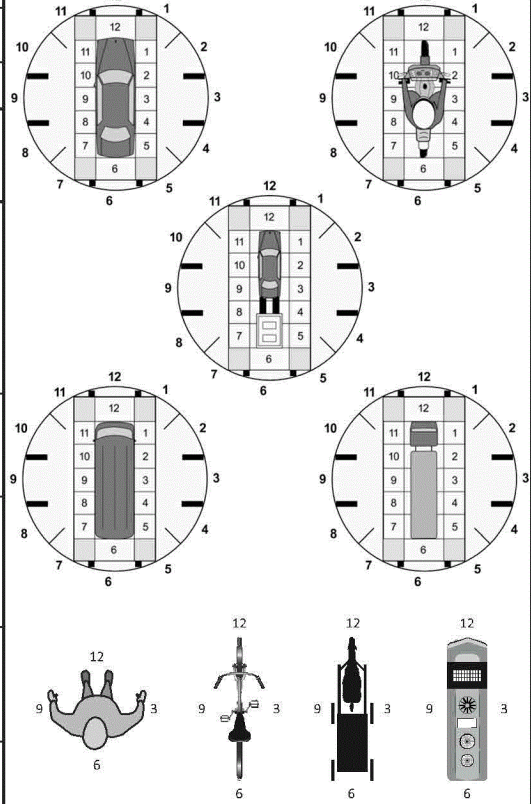
