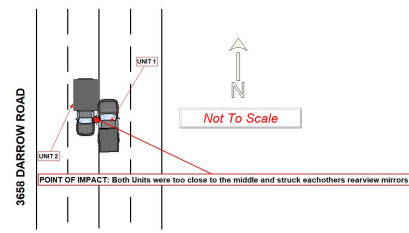
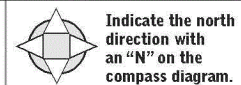

**Unit 1 was traveling northbound on Darrow Road in the left lane. Unit 2 was traveling southbound on Darrow Road in the left lane. Unit 1 was attempting to make a left turn onto 3658 Darrow Rd. Unit 1 was positioned too far to the left on the yellow lines and Unit 2 was traveling closely to the yellow lines on its left as well. As a result, Unit 2's driver's side rearview mirror struck Unit 1's driver's side rearview mirror. Both Units contributed to the accident.**
