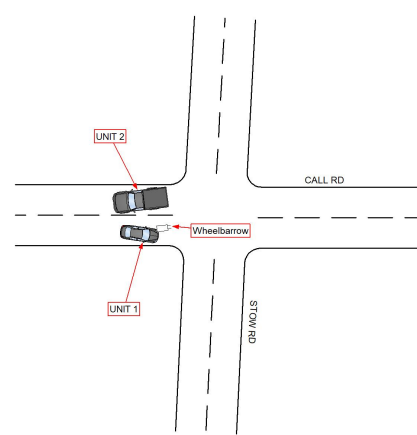

NARRATIVE

Unit 1 was traveling eastbound on Call Road towards the intersection of Stow Road and Call Road. Unit 2 was traveling southbound on Stow Road and made a right turn on Call Road, traveling westbound. While Unit 2 was initiating the right turn, an unsecured object, a wheelbarrow, fell from Unit 2 towards Unit 1. As a result, Unit 1 was struck in the front left bumper by the wheelbarrow.

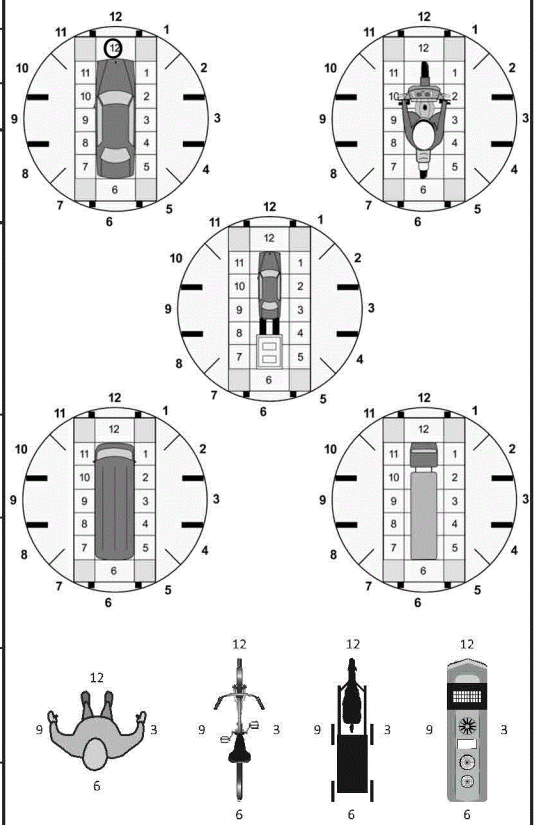
