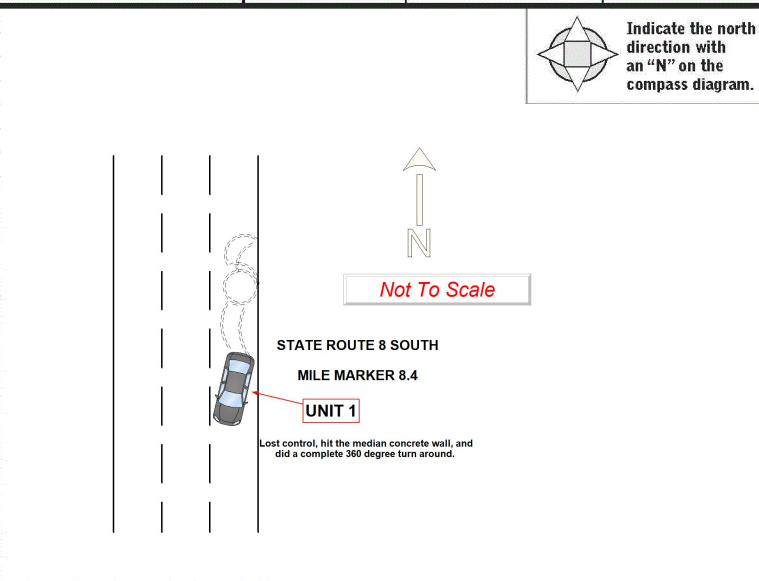

NARRATIVE
Unit 1 was traveling southbound in the left lane near the median concrete barrier on State Route 8. While driving, Unit 1 failed to maintain control and crashed into the median concrete barrier with the left side of its vehicle, then made a complete 360 turn around in the lane. Unit 1 was facing southbound at the end of its collision with the median concrete barrier. As a result, all sides of the vehicle were damaged, airbags were deployed, and a fire started near the front left wheel of Unit 1. Unit 1 was towed from the scene.

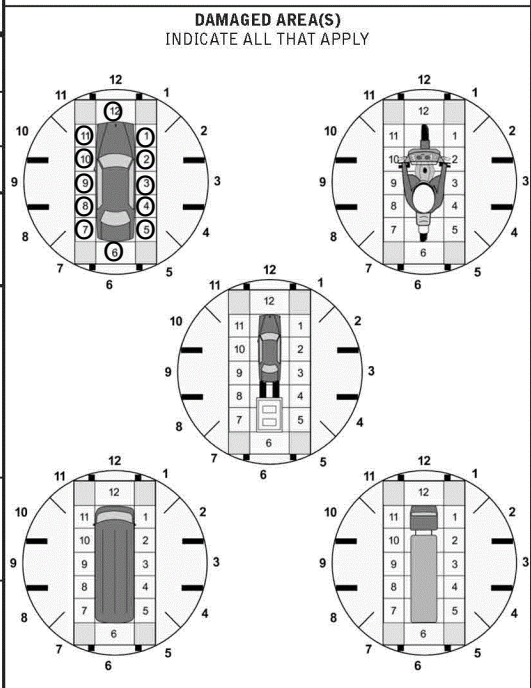

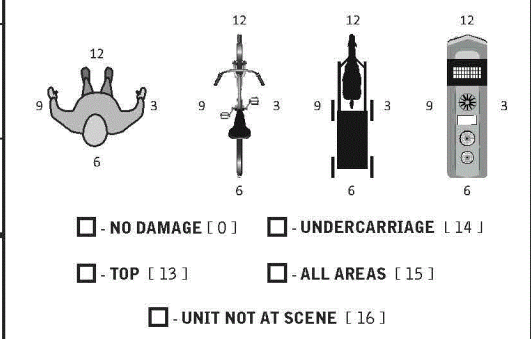
