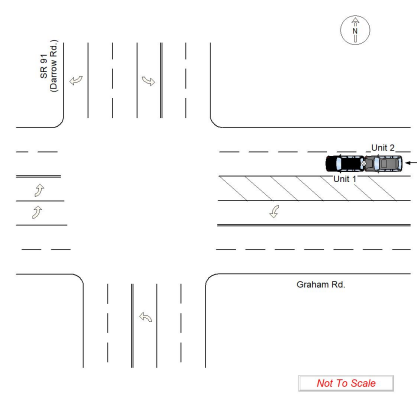

The driver of the car in front of mine opened his door and so did I we both exited our cars and inspected the cars. His car showed a small mark or scuff on the bumper. He called the police and we moved our cars to a parking lot of Flynn's Tire.

While waiting for the police officer I commented to the other driver that I wasn't convinced that I had actually hit his car. At that point the front seat passenger said that I had hit them so hard that she had a pain in her neck, and the passenger in the back seat yelled that I had ramed into them, and rear ended them. The passenger in my car didn't think that I had hit them at all or it might have been just a tap. My foot was never on the accelerator during this incident
