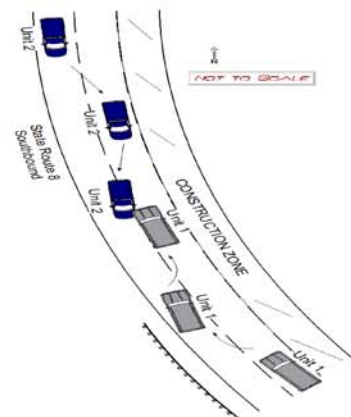
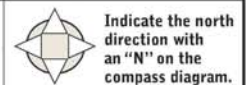

NARRATIVE
Unit 2 was traveling southbound on State Route 8 approaching the 8.2 mile marker. Unit 1 was traveling, the wrong way, northbound on State Route 8 approaching the 8.2 mile post. Unit 2 changed from the left lane to the right lane then back to the left lane attempting to avoid Unit 1 as it was drifting between lanes. At the last second Unit 2 changed from the left lane to the right lane in an attempt to miss Unit 1, but was unsuccessful and was struck on his driver's side.
Additional damage reported for Unit 2.

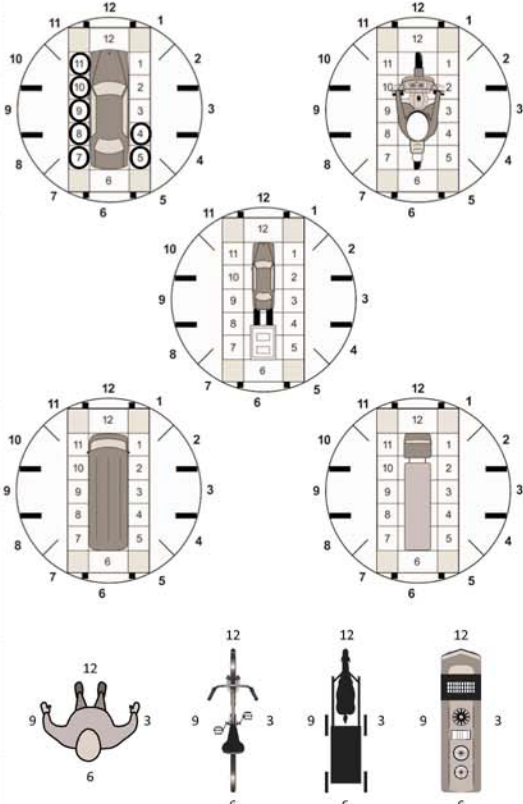
