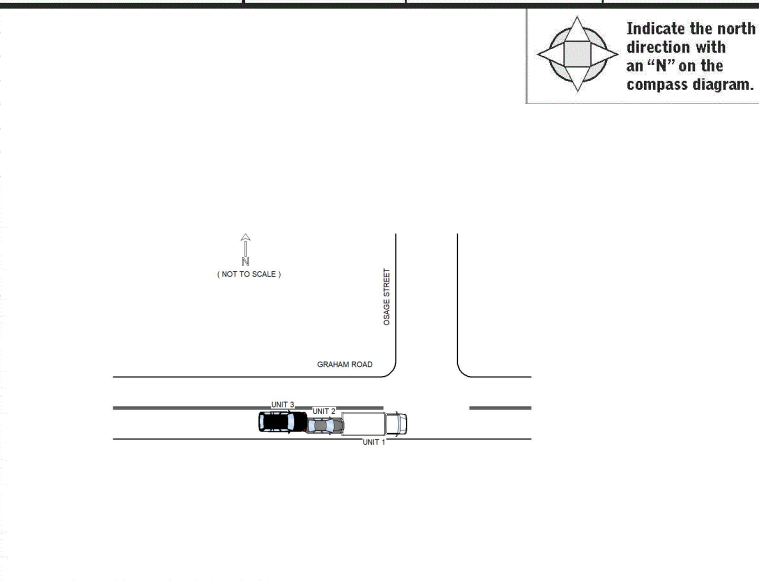

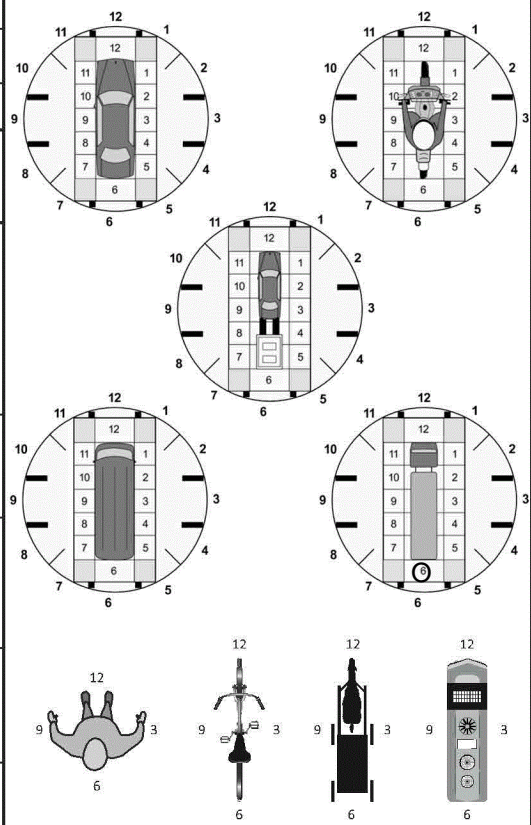

It does not appear that he tried to slow down at all. It appears he was going between 35-40 mph. I have submitted all of the dashcam footage as evidence. After we were hit, I immediately got out of the car to grab my daughter. After making sure my daughter was alert and moving, I knocked on the other drivers window because he still hadn't gotten out of his vehicle. He then opened the door and had a big gash on his forehead that was bleeding. He told me that he has a nerve condition and tried pressing the brake but his foot slipped off and he couldn't stop.
