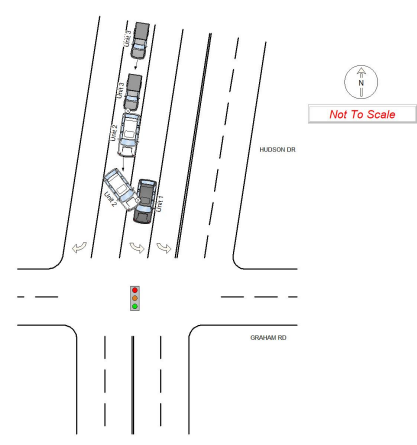

**Unit 1 was stopped at the Hudson Dr/Graham Rd intersection. Unit 1 was in the left lane to turn east onto Graham Rd. Unit 2 was stopped at the Hudson Dr/Graham Rd. Unit 2 had its left-turn signal on to enter the left-turn lane. Unit 3 was traveling southeast on Hudson Dr. Unit 3 did not keep an assured clear distance ahead and struck Unit 2, causing Unit 2 to strike Unit 1. Unit 1 and Unit 2 declined to provide a written statement. An independent witness observed the accident and provided a statement.**

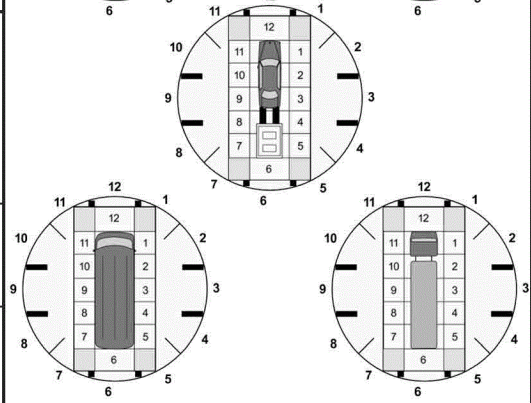

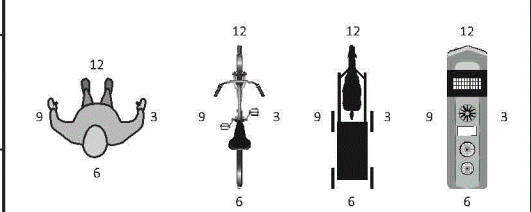
