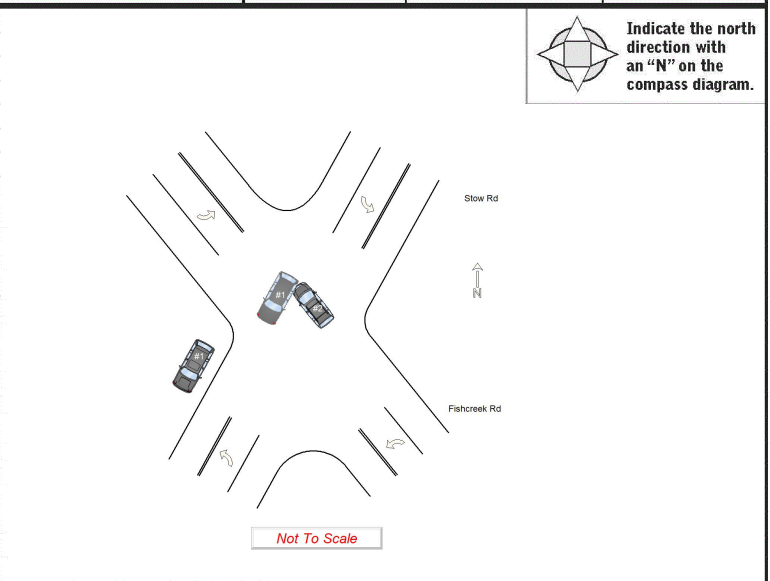

NARRATIVE

Unit #1 was traveling southwest on Stow Rd, approaching Fishcreek Rd. Unit #2 was traveling northwest on Fishcreek Rd, approaching Stow Rd. Unit #2 stated that her traffic signal turned yellow. She stated she attempted to stop but slid into the intersection. Unit #1's light had turned green, so she entered the intersection. Unit #2 struck the left rear of Unit #1. The impact forced Unit #1 off the right side of the roadway, where Unit #1 rolled onto its passenger side.
