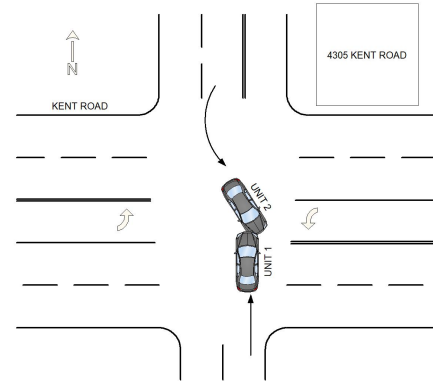
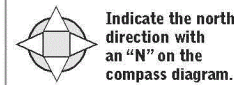

Unit 1 was leaving the Hobby Lobby plaza and proceeding northbound over Kent Rd. into the Wendy's plaza (4305 Kent Road). Unit 2 was leaving the Wendy's plaza heading south and turning east onto Kent Road. Unit 2 failed to yield while making a left turn and was struck by Unit 1. Both reported they had a yellow light at the time of the impact.

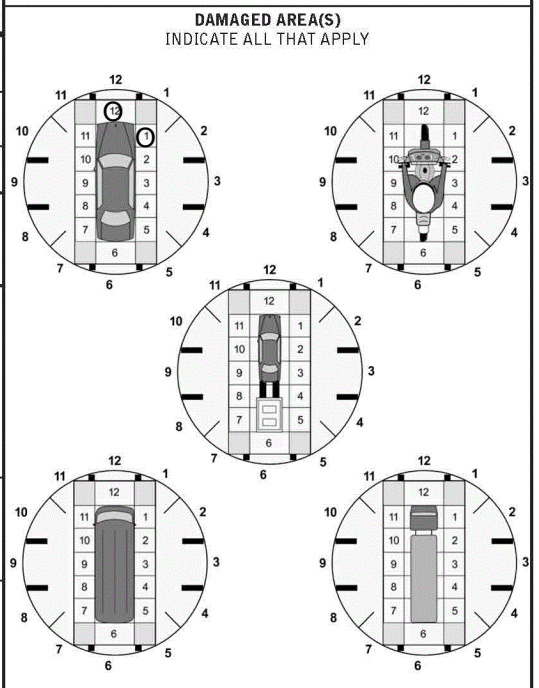

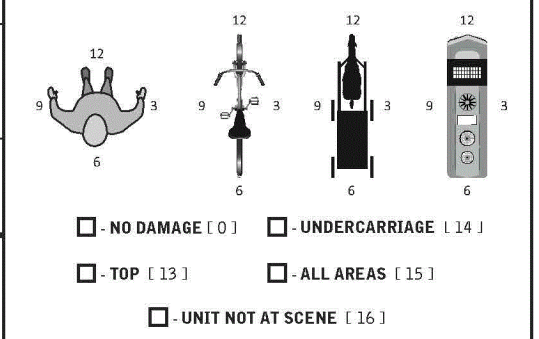
