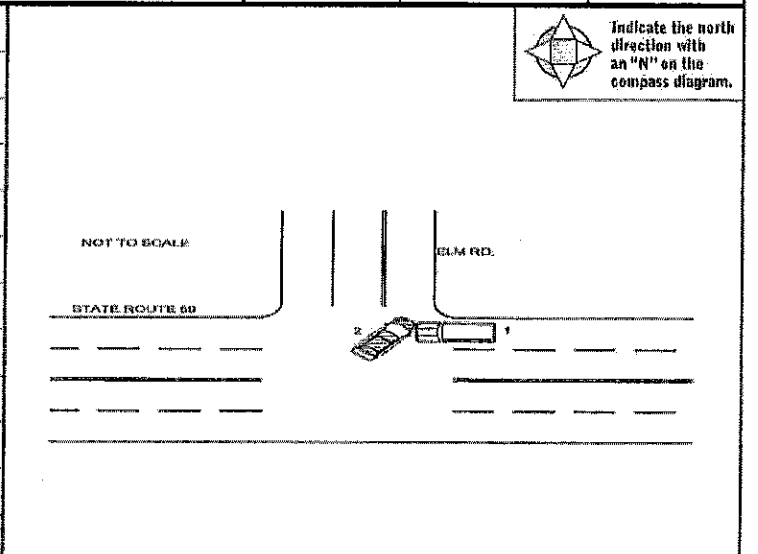

UNIT #2 FAILED TO YIELD THE RIGHT OF WAY TO ONCOMING TRAFFIC AND TURNED LEFT BEFORE IT WAS SAFE TO DO SO, CAUSING UNIT #1 TO STRIKE UNIT #2 IN THE RIGHT SIDE.
