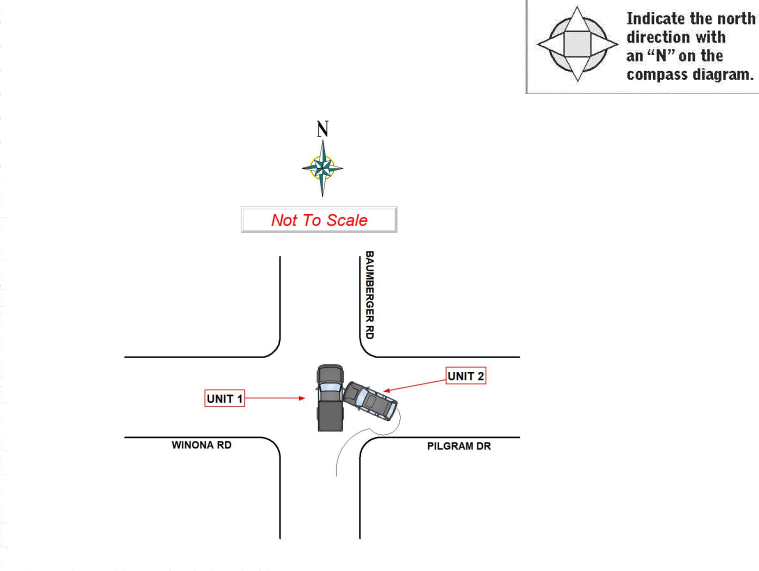

NARRATIVE  
**Unit 2 was traveling northbound on Baumberger. Unit 1 was traveling directly behind Unit 2. Unit 2 made a right turn eastbound onto Wynonna, but changed their mind and began to turn around to travel westbound on Wynonna. While Unit 2 was initiating its U-turn, Unit 1 continued forward. As a result, Unit 2's front left bumper struck Unit 1's passenger side doors at an angle.**

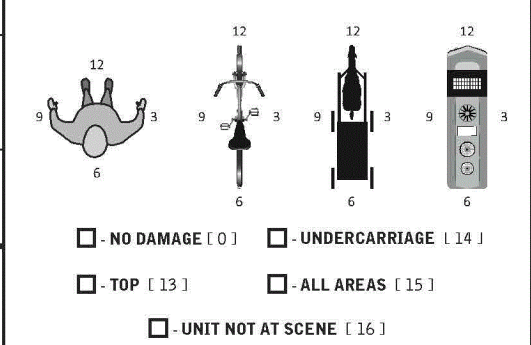
