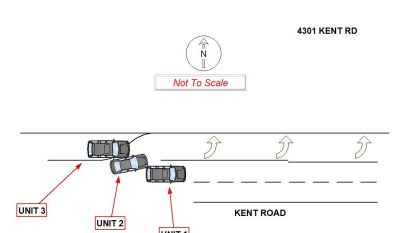
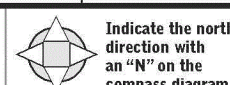

Unit 1 was stopped in traffic eastbound on Kent Road in the center lane. Unit 2 was stopped in traffic behind Unit 1 and attempted to go into the left turn lane. As Unit 2 was merging over into the left turn lane, Unit 3 was driving in the hazard zone in the left turn lane area. As a result, Unit 3 struck Unit 2, then Unit 2 struck Unit 1.
