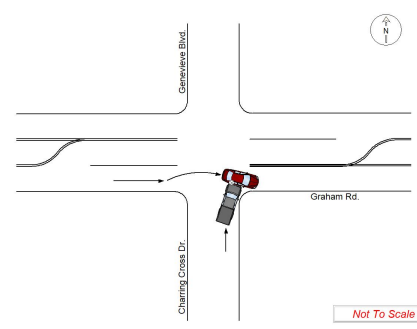

NARRATIVE

Unit 1 was traveling east on Graham Rd. approaching the traffic light at Charring Cross Dr. Unit 2 was stopped on Charring Cross Dr. signaling to make a right turn onto Graham Rd. Unit 2 stated they were attempting to make a right turn while their signal was red. As Unit 1 entered the intersection, its signal was yellow. Unit 2 entered the intersection before it was safe to do so. Unit 1 swerved to avoid Unit 2, then swerved back to avoid oncoming traffic, and struck the front of Unit 1.

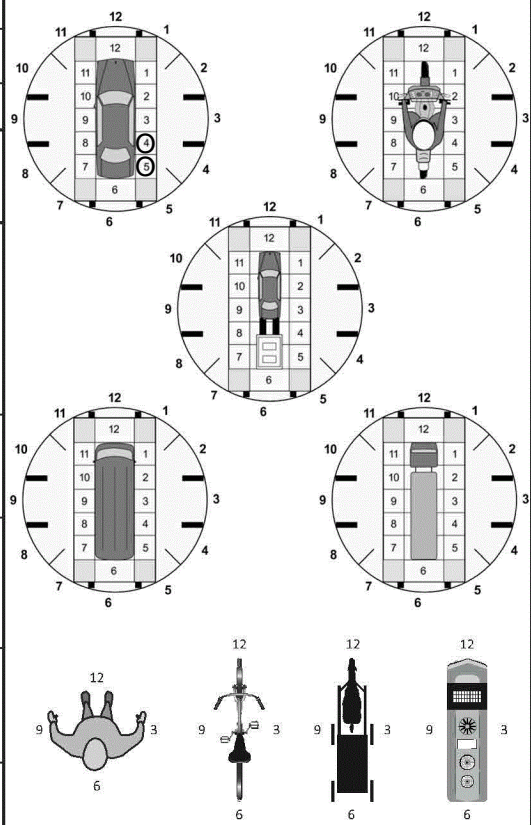
