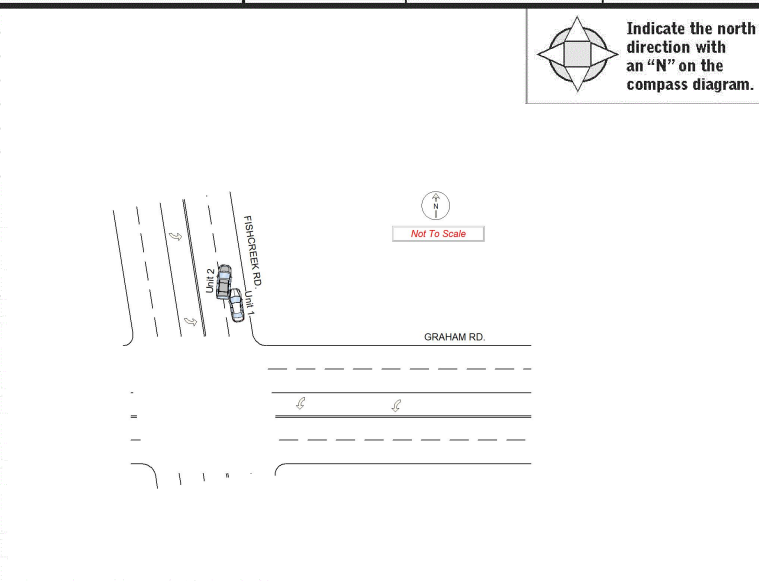

**Unit #1 was westbound on Graham Rd. turning right (northbound onto Fishcreek Rd.) Unit #1 and a separate witness reported unit #2 encroached into the lane of unit #1, striking unit #1. Unit #2 failed to stop and fled northbound on Fishcreek. Unit #1 and the witness followed unit #2, but lost track on back roads. A Flock camera captured unit #2 fleeing the scene. Police made contact with unit #2. Unit #2 claimed he was northbound on Fishcreek when unit #1 had pulled out and struck his vehicle. He admitted to not stopping for the crash.
