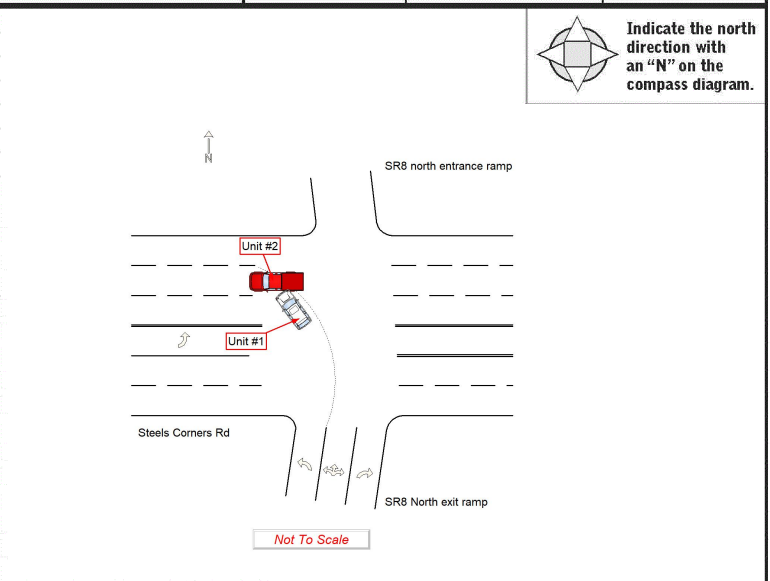

Unit #1 was exiting SR8 north onto Steels Corners Rd.

Unit #1 had a green light and proceeded into the intersection with the intention of turning left (west) onto Steels Corners Rd. Unit #2 was westbound on Steels Corners Rd in the middle westbound lane and ran the red light at the SR8 north exit/entrance ramp, driving directly into Unit #1's path. The front right of Unit #1 struck the left side of Unit #2.
