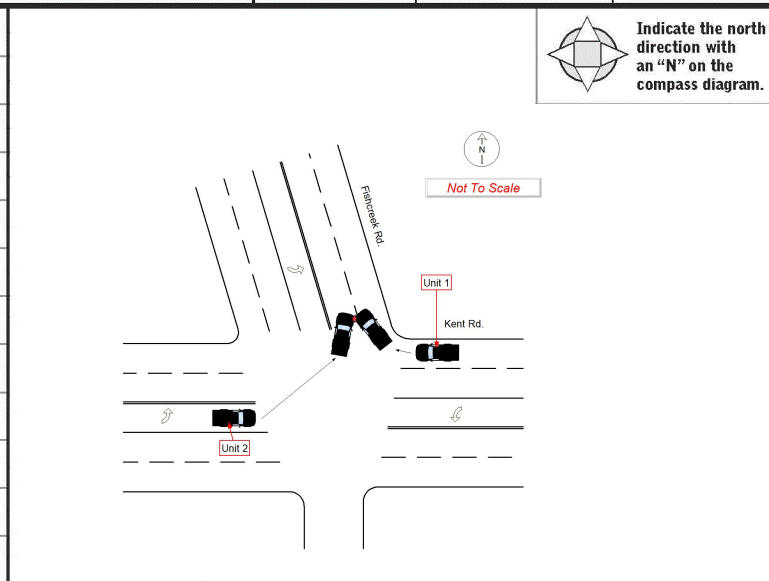

Unit 1 was traveling east on Kent Rd approaching Fishcreek Rd in the right lane. Unit 2 was stopped in the left turn lane at the red light, facing east on Kent Rd. Unit 2 received a green arrow to turn left onto Fishcreek Rd. Unit 2 began to turn left and entered the left lane to travel northwest on Fishcreek Rd. At the same time, Unit 1 made a right turn onto Fishcreek Rd. Unit 1 made an improper turn, and began to enter the left lane, striking Unit 2.
