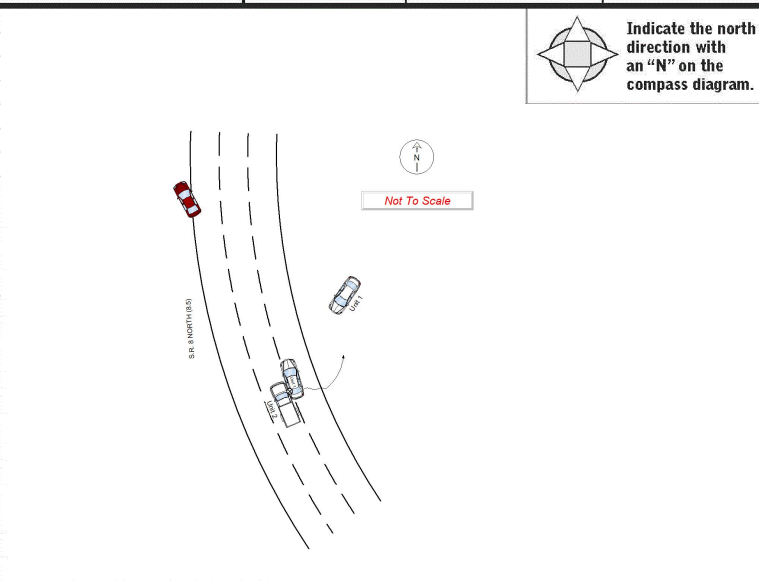

TWO OTHER UNITS FROM PRIMARY CRASH CAUSED IMMEDIATE MERGE OF MULTIPLE VEHICLES. UNIT #1 AND UNIT #2 STRUCK IN UNKNOWN SEQUENCE WHILE AVOIDING OTHER VEHICLES, UNIT #1 SPUNOUT AND CAME TO REST OFF ROADWAY.
