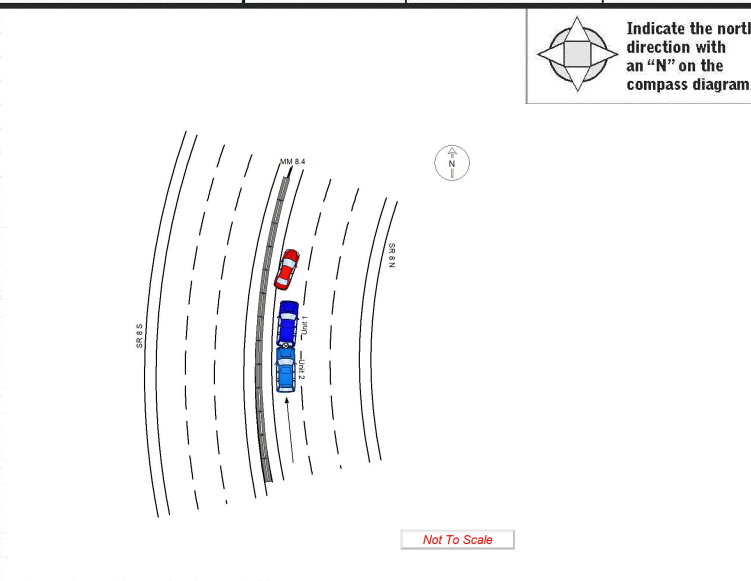

Unit 1 was traveling on SR 8 N in the left lane near MM

8.4. Unit 2 was traveling directly behind Unit 1. As Unit 1 entered the curve, the vehicle in front of Unit 1 swerved to avoid another vehicle stopped in the left lane. Unit 1 was able to stop and avoid a collision with the stopped vehicle, but Unit 2 was unable to stop in time, striking the rear of Unit 1.

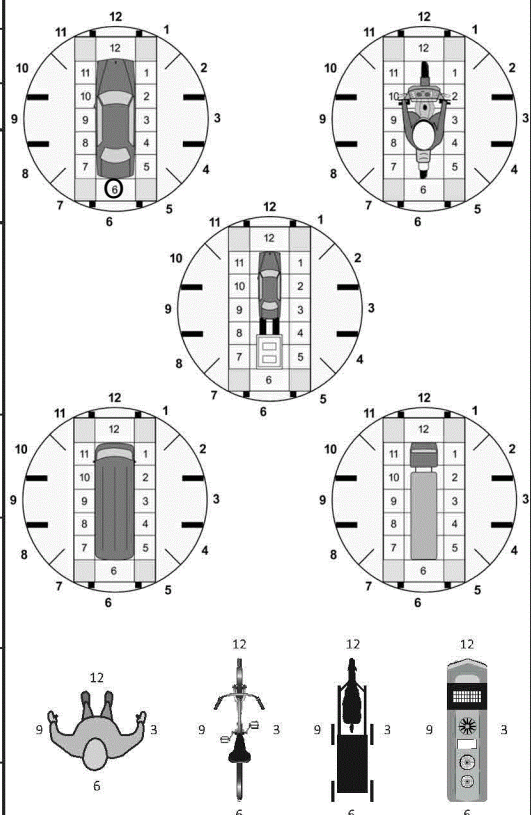
