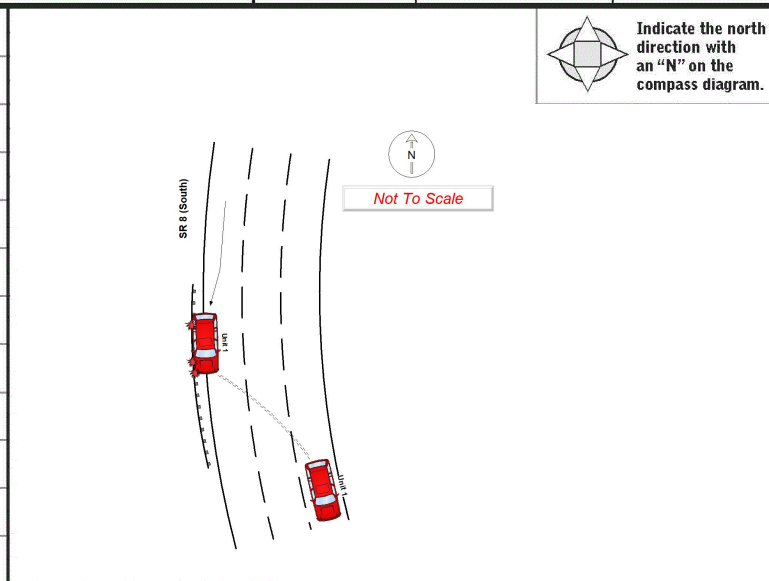

The driver of Unit 1 stated they had purposely exited the lane due to another vehicle in the center lane beginning to merge right, near Unit 1.
