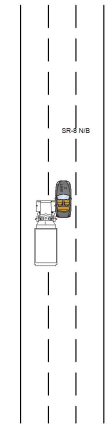

NARRATIVE  
**Both units were traveling slowly northbound on SR-8 in traffic backed up from another crash near milepost 8. Unit-1 was in the left lane, and unit-2 was in the middle lane in the blind spot of unit-1. Unit-1 states a citizen waved him over as they were all getting closer to the crash ahead. Unit-1 did not ensure it was clear and failed to maintain his lane, making contact with Unit-2 on the passenger-side front tire of his dump truck.**

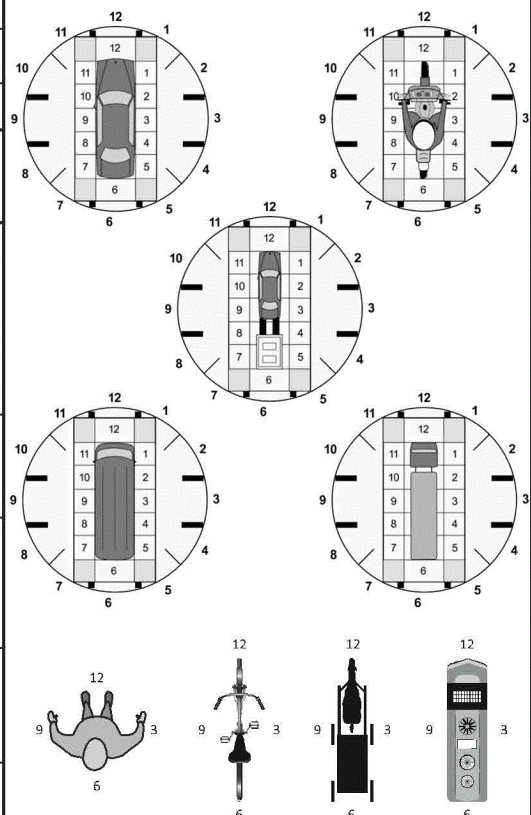
