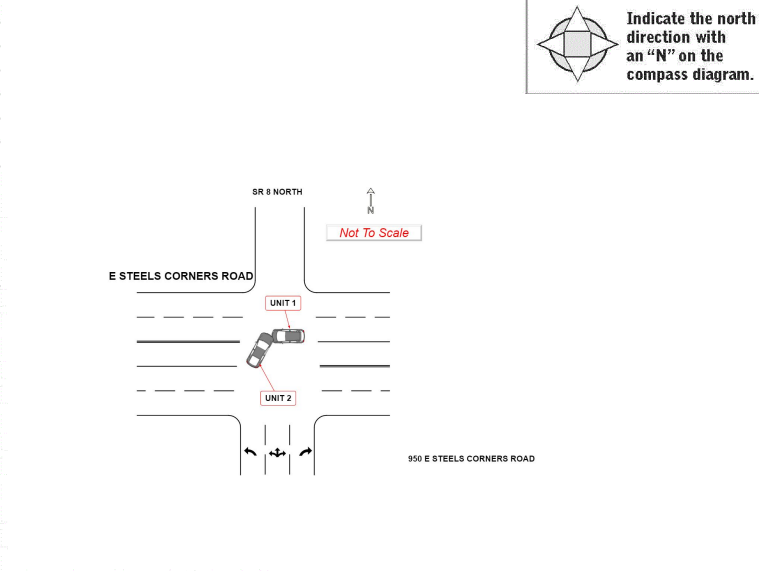

Unit 1 was traveling westbound on East Steels Corners Road approaching the intersection of State Route 8 northbound. Unit 2 was traveling eastbound on East Steels Corners Road approaching the same intersection. Both units had green lights. Unit 2 attempted to complete a left turn while Unit 1 was traveling straight. Unit 2 failed to yield to Unit 1, and the two units collided in the middle of the intersection.
