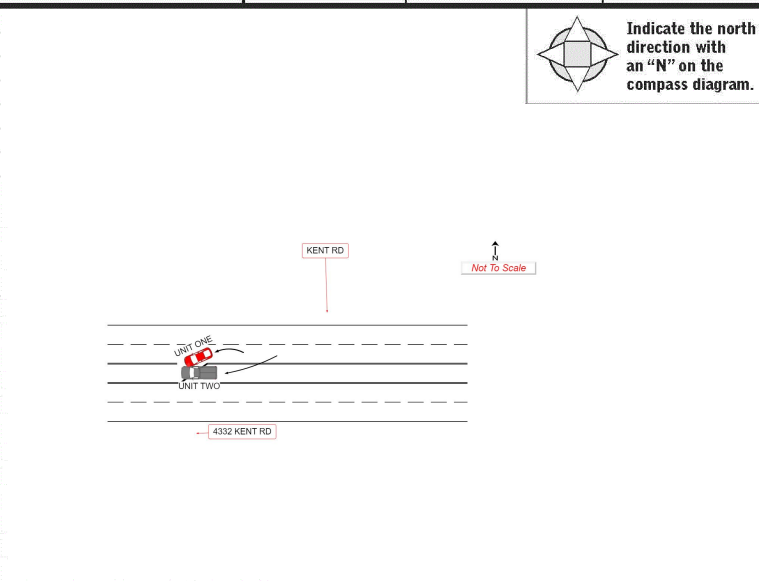

I was going to transition from being in the straight lane to the left lane, I prefaced by having my left blinker on and checking my mirrors and windows to go into the Dollar Tree parking lot on Kent Rd in Stow. As I was transitioning from one lane to the next, a black truck rushed up to me and hit the left side of my vehicle. We then parked in the Dollar Tree parking lot, I got out of the car to check on the other party. They said that they were fine and that "Everything will probably be okay. Let me get your phone number and talk to my dad, I was in a more serious car accident two weeks ago." I then put my phone number into his phone, he thanked me, said he would let me know what his dad said and drove away at 2:37pm. I sat in the parking lot until 3:05pm to compose myself before I went home to consult my mother, go to our insurance office, and come to the Stow Police Department to file a report. While I was at Eveningstar Insurance consulting our insurance provider, my provider called the other party's father, who said that I drove away and fled the scene in which police arrived. From the point of the accident which was shortly after 2:30pm to 3:05pm I sat in the parking lot and no law enforcement had ever arrived at the scene.
