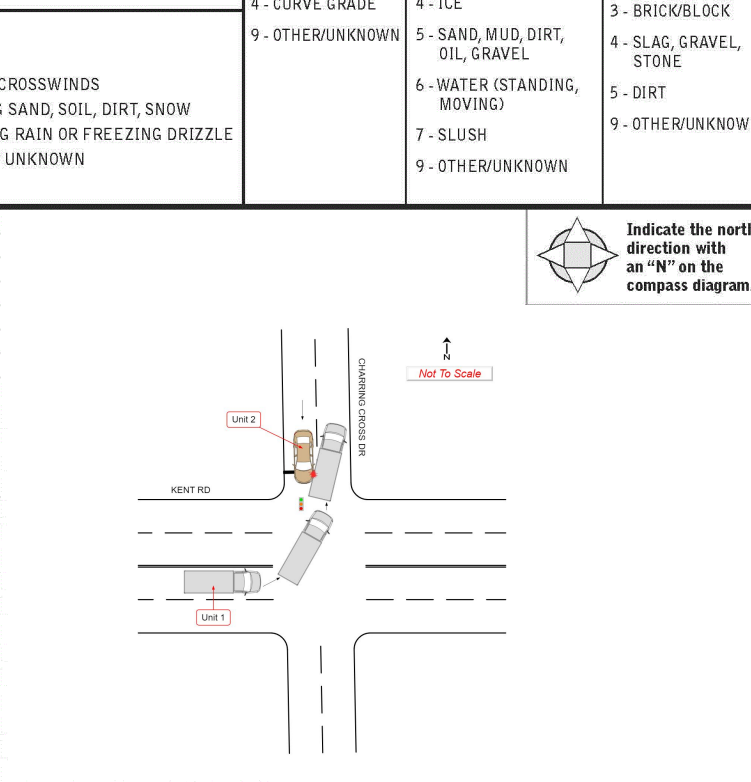

Unit 1 was traveling east on Kent Rd in the left lane near Charring Cross Dr. Unit 1 began to make a left turn onto Charring Cross Dr. to travel north. Unit 2 was traveling south on Charring Cross Dr. approaching Kent Rd. Unit 2 failed to stop at the stop bar and struck Unit 1 as it was making the turn. As well as Unit 1 made an improper turn, striking Unit 2.

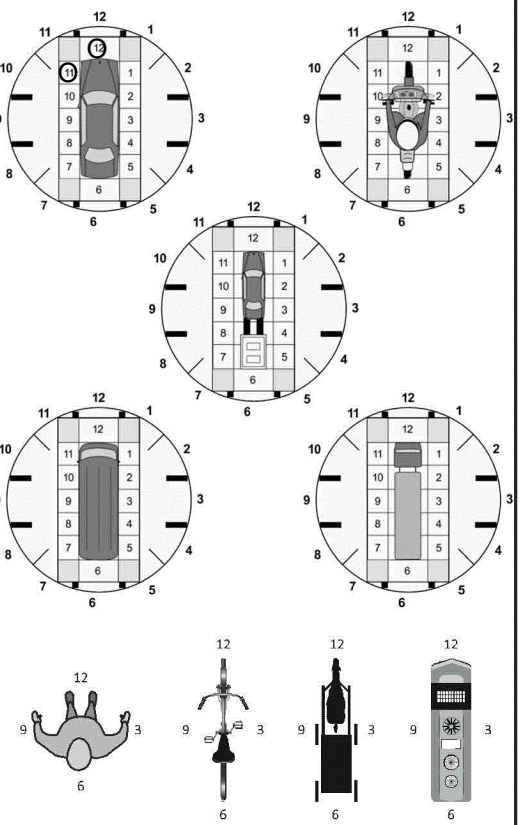
