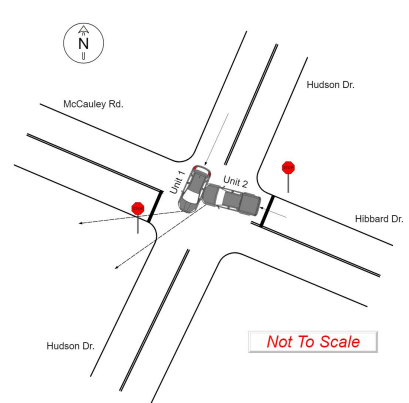

Unit 1 was traveling southbound on Hudson Dr. Unit 2 was traveling westbound on Hibbard Dr. Unit 2 was stopped at the stop sign at Hudson Dr. and Hibbard Dr., attempting to travel straight onto McCauley Rd. Failing to yield, Unit 2 crossed Hudson Dr., striking the side of Unit 1. The impact of the collision resulted in both units running off the road on the southwestern corner of the intersection.

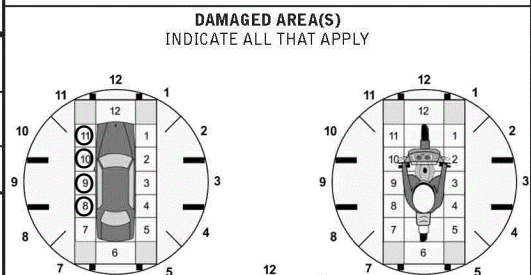

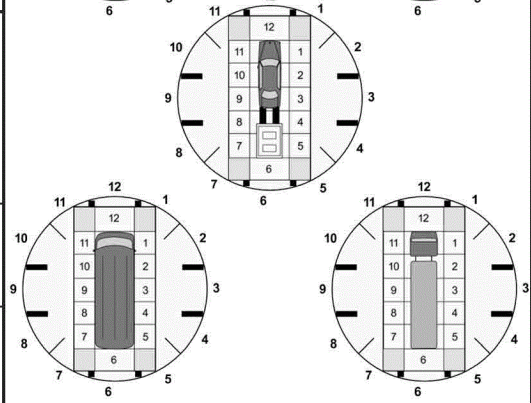

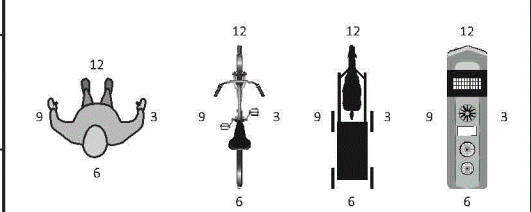
