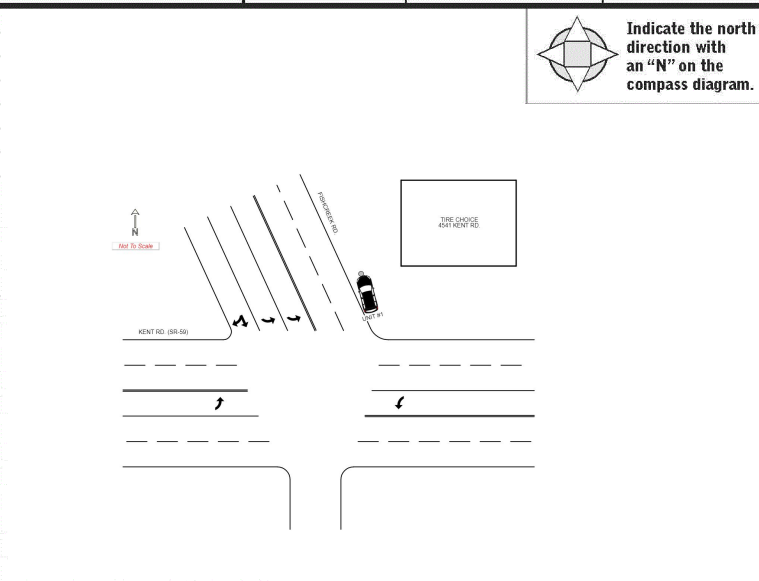

**UNIT #1 WAS TRAVELING EASTBOUND ON KENT RD. (SR-59). UNIT #1 ATTEMPTED TO MAKE A LEFT-TURN FROM KENT RD. (SR-59) TO HEAD NORTHBOUND ONTO FISHCREEK RD. WHILE TURNING, THE DRIVER OF UNIT #1 FAILED TO CONTROL THE VEHICLE. AS A RESULT, UNIT #1 STRUCK THE CURB AND DROVE OFF OF THE ROAD TO THE RIGHT. THE FRONT END OF UNIT #1 THEN STRUCK A UTILITY POLE.**
