DESCRIBE WHAT HAPPENED

Unit 1 was parked facing south. Unit 2 backed into Unit 1, got out to look at the damage, and fled the scene. The driver of Unit 2 was identified by a witness. I attempted to contact their listed address. The vehicle was parked on the street with the rear tire on the curb. I did not receive any answer at the door, despite the ADT camera that appeared to be activated. Suspect made no attempt to report this accident. On 2/20 at 1412 I called the suspect twice and left a voicemail. The suspect contacted me back at 1634. She stated that there was nobody there, no damage and she had to get back to work. She stated she works from home and was on a meeting with 10 people. Suspect was cited with Hit-Skip on Private Property. A recording from my conversation with the suspect has been included, along with photos and a witness statement.

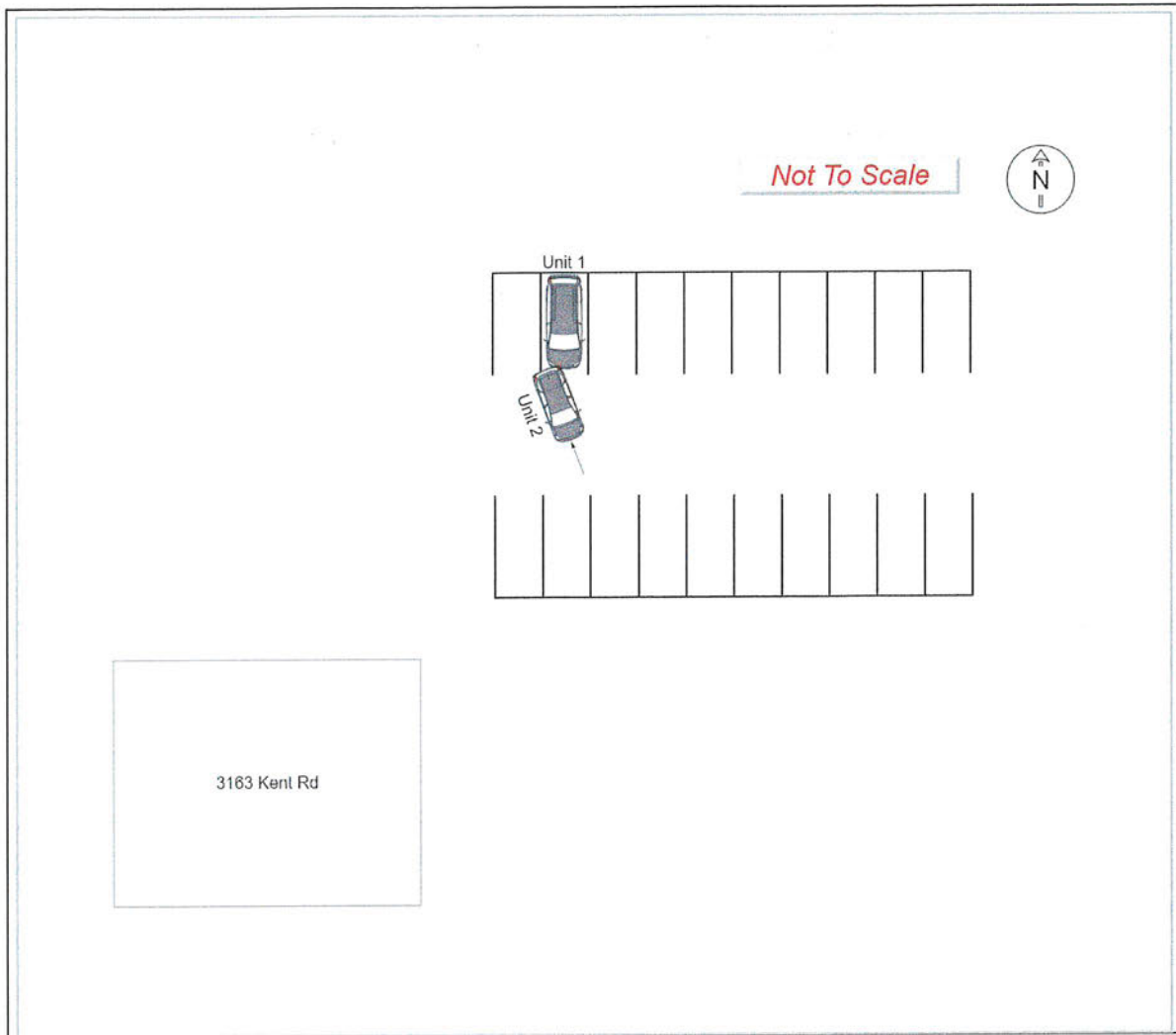
