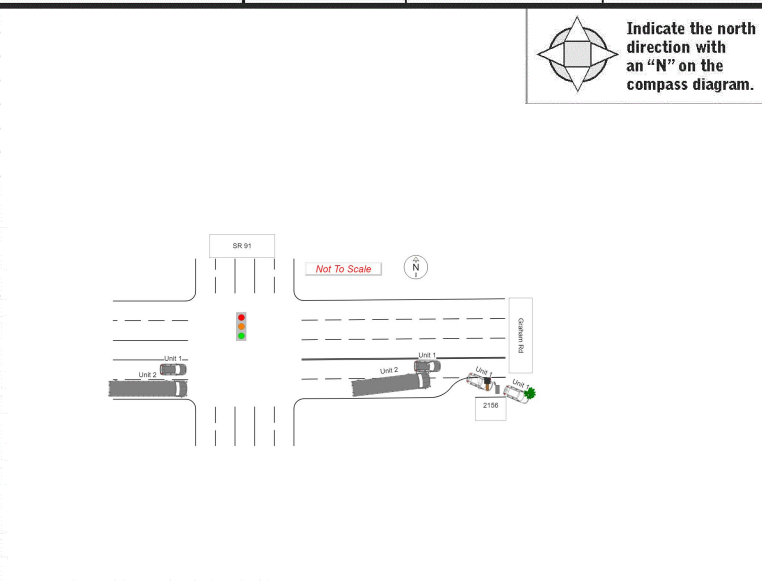

UNIT 1 WAS EAST ON GRAHAM RD STOPPED AT THE SR 91 TRAFFIC SIGNAL IN THE LEFT LANE. UNIT 2 WAS IN THE RIGHT LANE. WHEN THE LIGHT TURNED GREEN, UNIT 2 ATTEMPTED TO SPEED AHEAD OF THREE VEHICLES AND MERGE LEFT DUE TO THE LANE ENDING. UNIT 2 STRUCK UNIT 1, CAUSING UNIT 1 TO DRIVE OFF THE ROAD RIGHT, STRIKE A MAILBOX, A TRASH CAN, AN ADDRESS SIGN, AND A TREE AT 2156 GRAHAM RD. UNIT 1 ALSO TURFED THE

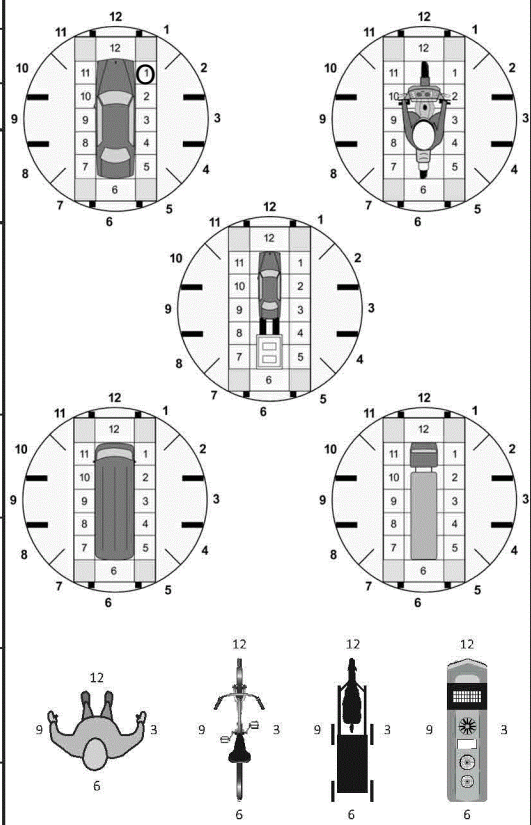

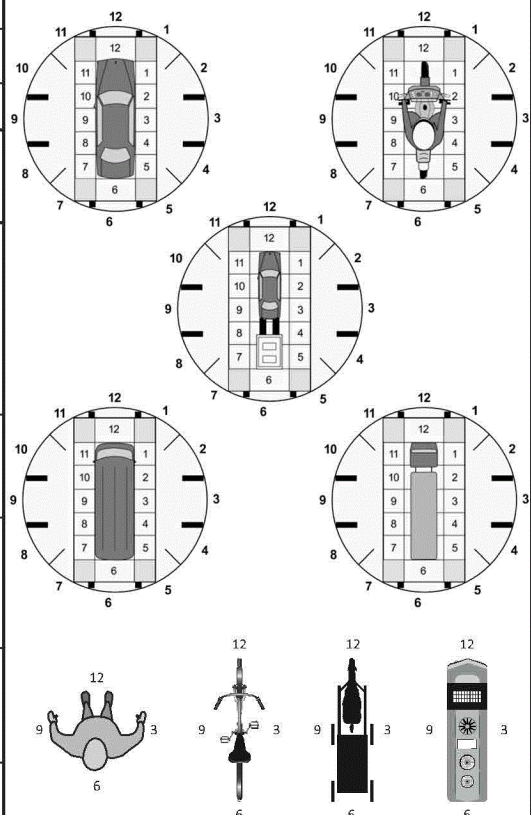
