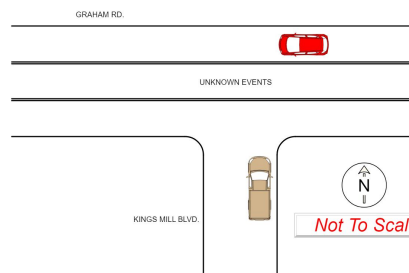
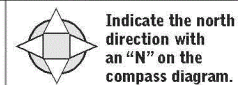

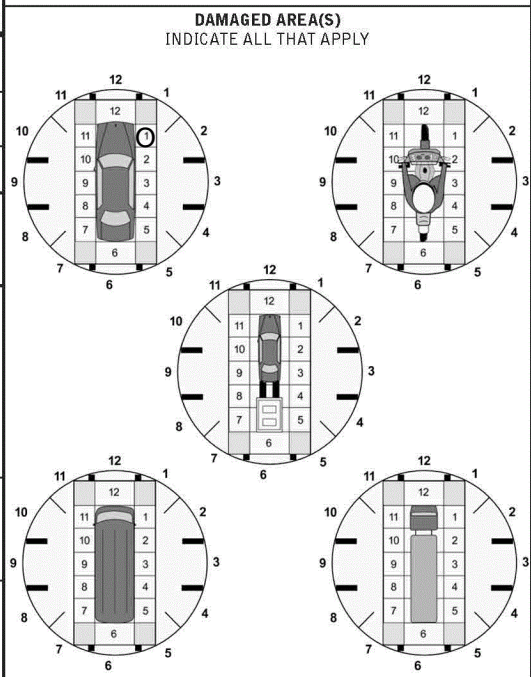

Police contacted Unit #2, who returned to the high school to speak to officers. Unit #2 reported that he turned left from Kings Mill Blvd. onto Graham Rd. pulling in behind Unit #1. He denied any collision with Unit #1. There was no visible damage to Unit #2. The ride height of Unit #2 places the bumper and body panels higher than the damage to Unit #1.

Both parties gave conflicting statements. There was no matching damage to substantiate a collision between the two units.
