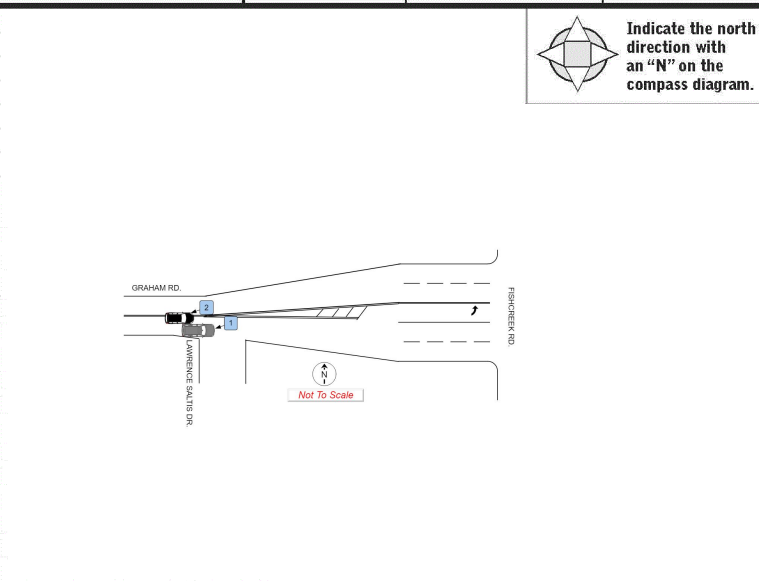

UNIT #1 WAS STOPPED IN TRAFFIC EASTBOUND ON GRAHAM RD. AT LAWRENCE SALTIS DR. APPROACHING THE INTERSECTION OF FISHCREEK RD. THE ROADWAY WAS A TWO LANE ROAD BUT JUST BEGINNING TO BREAK OFF INTO FOUR LANES. UNIT #2 WAS EASTBOUND BEHIND UNIT #1 AND WENT LEFT TO PASS UNIT #1 BEFORE THE LANES FULLY OPENED. UNIT #2 DROVE OVER THE MARKED LANES IN THE ROAD AND SIDE SWIPED UNIT #1.
