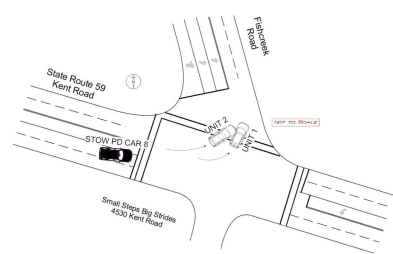

NARRATIVE
While in active pursuit of Unit 2 with lights and sirens activated on a marked police cruiser, Unit 2 recklessly drove around traffic while eastbound on Kent Road and turned northbound onto Fishcreek Road. While terminating the pursuit, Unit 2 was observed striking the side of Unit 1 as they made the left turn. Unit 1 sustained damage to their front driver side quarter panel and driver side mirror.
Unit 2 had three unknown female passengers also in the vehicle. Unit 2 did not have any visible license plate.
