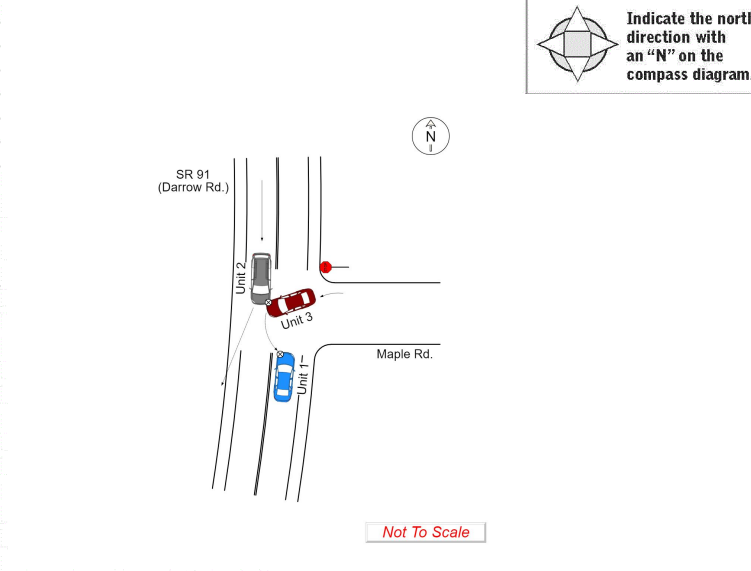

Unit 1 was stopped in traffic traveling north on SR 91 at Maple Rd. Unit 2 was traveling south on SR 91 approaching Maple Rd. Unit 3 was stopped on Maple Rd. at SR 91, signaling to make a left turn onto SR 91. As Unit 2 approached Maple Rd., Unit 3 made a left turn, pulling out in front of Unit 2. Unit 2 struck Unit 3, causing Unit 3 to strike Unit 1.

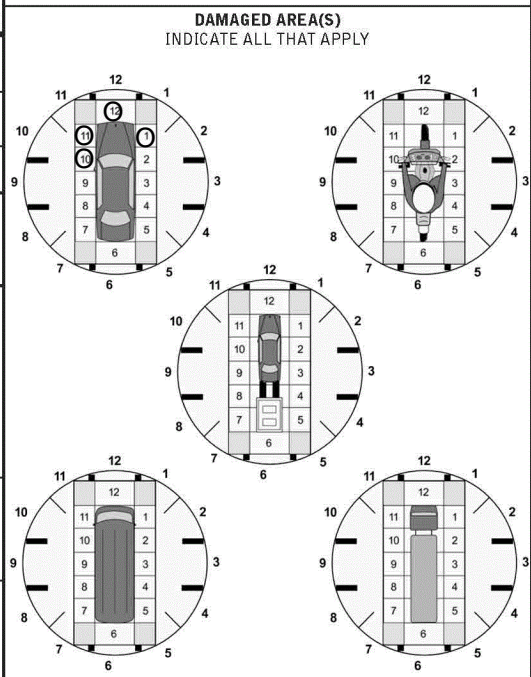
