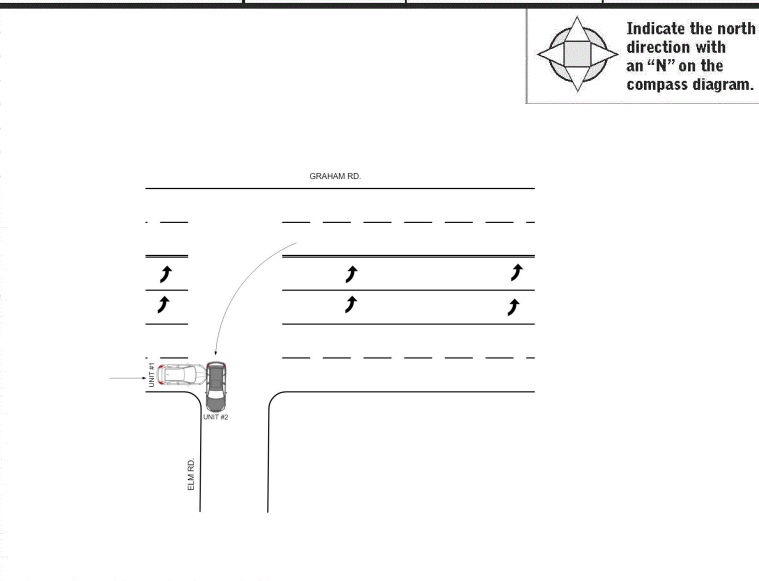

UNIT #1 WAS TRAVELING EASTBOUND ON GRAHAM RD. IN THE RIGHT-LANE APPROACHING ELM RD. UNIT #2 WAS TRAVELING WESTBOUND ON GRAHAM RD. IN THE LEFT-LANE APPROACHING ELM RD. UNIT #2 ATTEMPTED TO MAKE A LEFT-TURN TO HEAD SOUTHBOUND ONTO ELM RD. UNIT #2 FAILED TO YIELD TO THE RIGHT-OF-WAY OF UNIT #1 WHILE TURNING. AS A RESULT, THE FRONT-END OF UNIT #1 STRUCK THE REAR-PASSENGER SIDE OF UNIT #2.

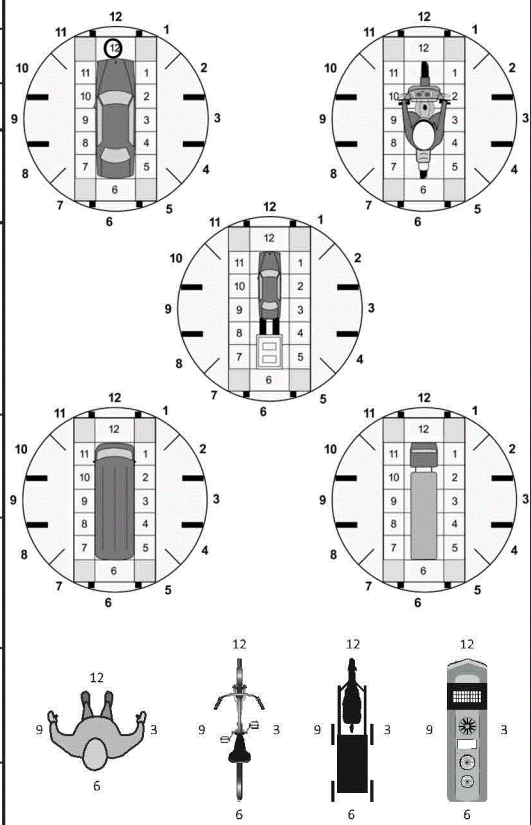
