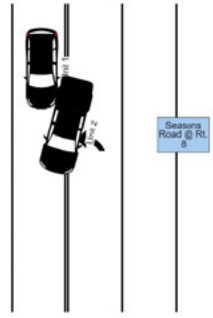

He acted as if he was going to drive away speeding up and again slamming on his brakes before pulling over, I stopped the two cars behind me.
