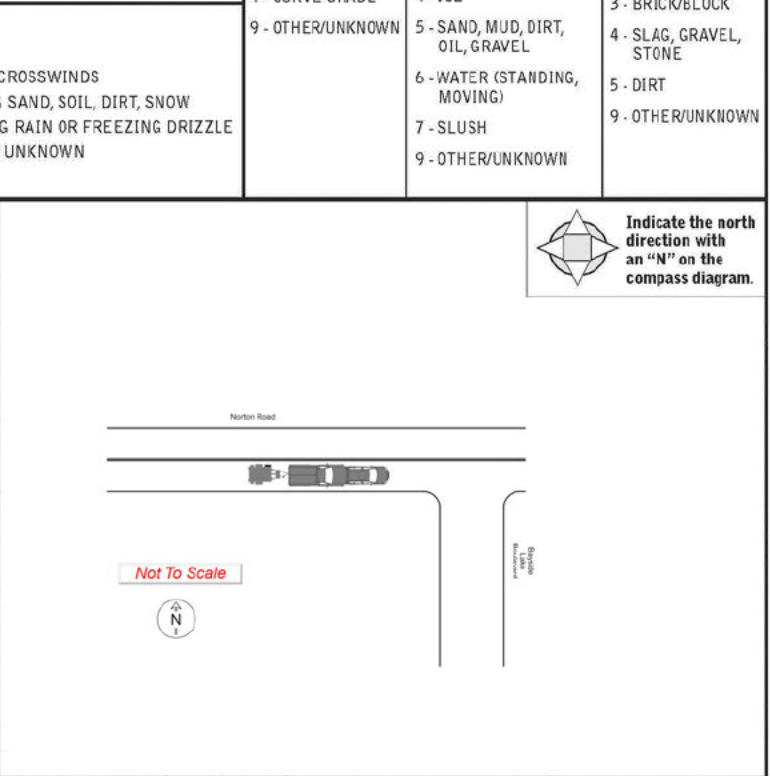

NARRATIVE

Unit #1 was eastbound on Norton Road approaching the intersection of Bayside Lake Boulevard. Unit #2 was directly behind Unit #1, hauling a trailer. Unit #1 slowed to make a right turn (southbound) on Bayside Lake Boulevard, and Unit #2 failed to maintain an assured clear distance ahead, striking Unit #1 in the rear.
