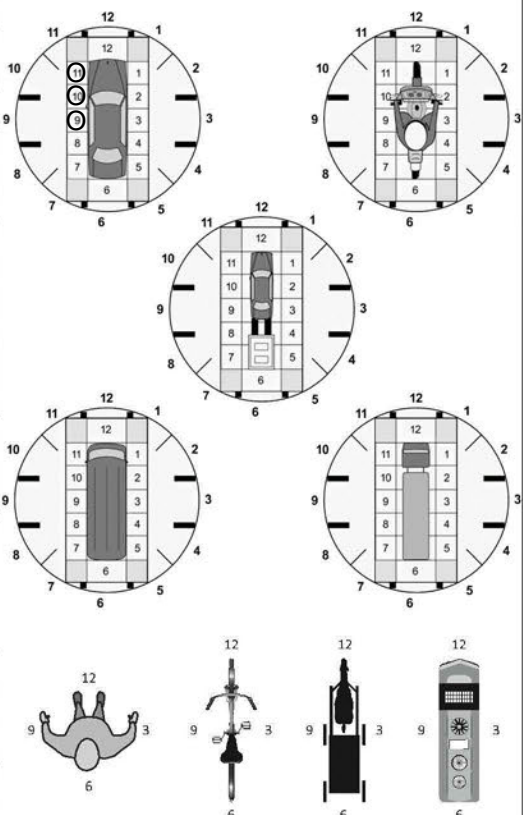

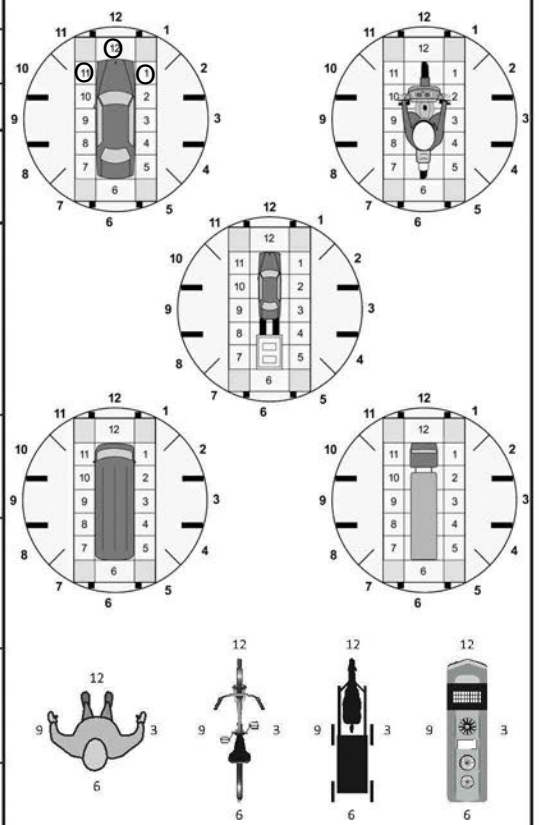

On 5/8/26, Cindy Soto spoke with Sgt Balog and advised him that the accident report was done incorrectly. She stated that she did not wish to have it changed because insurance was going to cover the repairs. Sgt Balog advised Cindy that she could come and complete an OH3 statement.

On 5/14/26, Sgt Balog requested assistance due to being off. He received a phone call from Cindy's insurance agent requesting that the report be changed due to inaccuracies. I spoke with Cindy, and she stated she was driving in the right lane, observed the DAV (Unit 1) ahead, and came to a stop. She stated that Unit 1 went to her right, wedging between her truck and the jersey barricade. The damage to Unit 2 and Unit 3 does not coincide with her statements.

I contacted the driver of Unit 3, Joshua Bell, and he provided a statement over the phone that was the same as documented in the accident report. I then reviewed Ofc Davidson's BWC from the incident. Cindy's statement on scene stated that she had no idea what had happened. Joshua's statement on scene was what was documented in the accident report. The location of the damage on Unit 3 is in line with his statement. If Cindy's statement was what occurred, the damage would be on the sides of Unit 3, rather than the front quarter panels. Given the statements made and location of the damage, the accident report will not be changed, and all evidence shows that Unit 2 is responsible for the crash of Unit 1 and Unit 3.

DIAGRAM ERROR CORRECTION

The initial diagram depicts the events that occurred according to the evidence and statements. However, Ofc Johnson incorrectly labeled Unit 1 and Unit 3. They are switched, showing the DAV as Unit 3.

Unit 3 in the diagram should be Unit 1. Unit 1 in the diagram should be Unit 3.

There is nothing further at this time.
