COMING UP TO THE STEELS CORNERS ROAD EXIT, I PASSED IT IN THE MIDDLE LANE OF ROUTE 8 SOUTH, AND PUT MY BLINKER ON TO MERGE ONTO THE FAR RIGHT HAND LANE, APPROXIMATELY 0.25 - 0.40 MILES BEFORE EXIT 7 GRAHAM ROAD.
