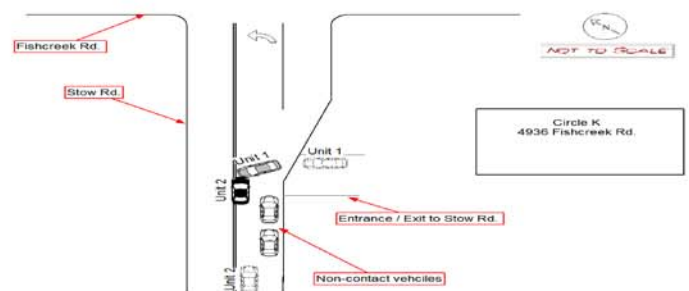
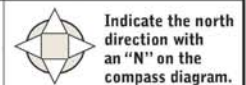

NARRATIVE
Unit #1 was exiting 4936 Fishcreek Rd. (Circle K) to turn left (south) onto Stow Rd. Unit #2 was northbound on Stow Rd. approaching the Fishcreek Rd. intersection. Two or three non-contact vehicles were stopped in traffic, with an opening for the Circle K entrance/exit. Unit #1 pulled out on the roadway failing to yield when exiting private property. Unit #2 went partially left of center, around the stopped vehicles, to enter the left turn lane for Fishcreek Rd. Units #1 and #2 collided.

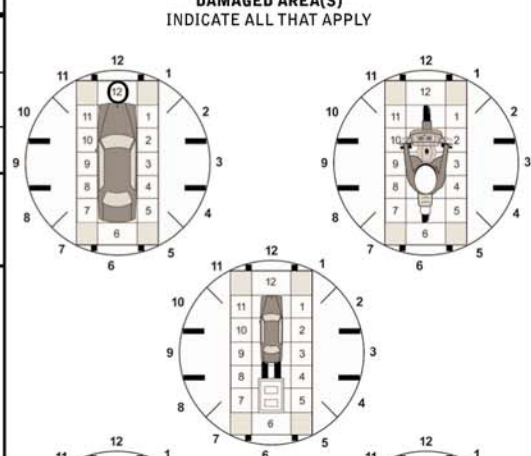

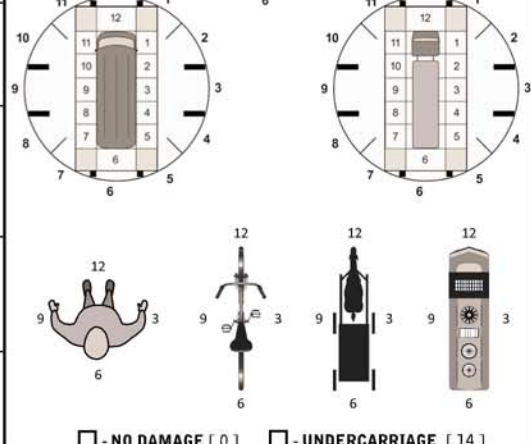

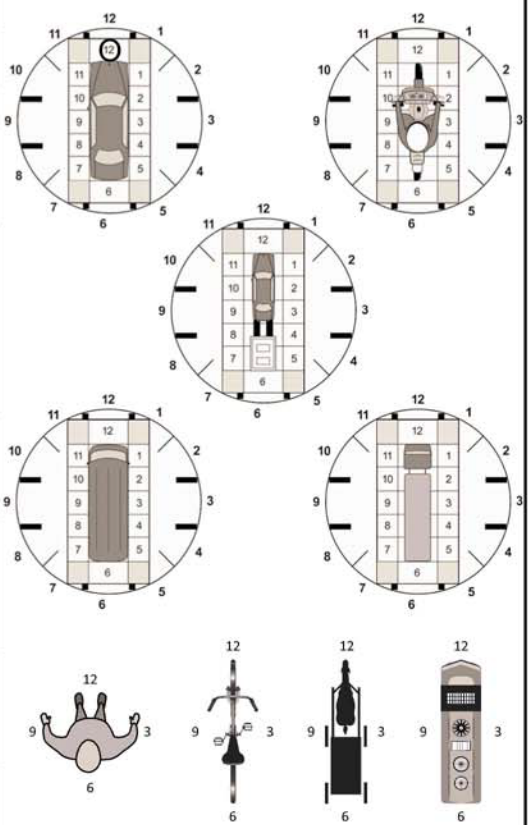
