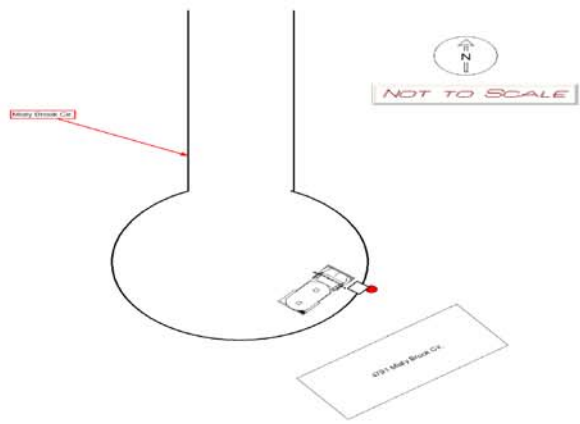
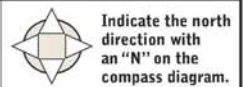

NARRATIVE

A third party citizen noticed a damaged fire hydrant and reported it to the Stow Water Department. It was suspected the damage was caused by garbage truck. Police contacted the refuse company and verified one of their vehicles had caused the damage.

Unit #1 was a garbage truck collecting refuse near 4791 Misty Brook Cir. While negotiating the curve of the cul-de-sac, the automatic claw struck a fire hydrant. Unit #1 attempted to report this to his company but was unable to reach a live operator.
