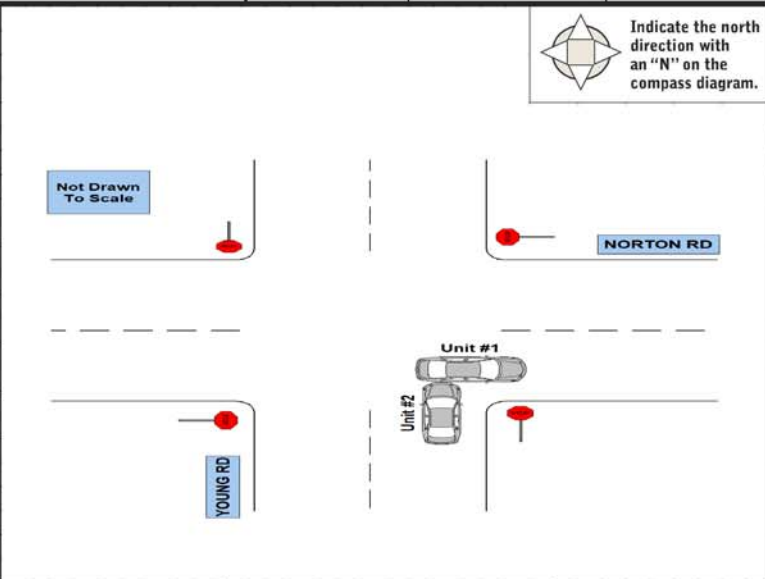

Unit #1 was operating eastbound on Norton Rd after stopping for the stop sign at the intersection of Young Rd. Unit #2 was operating northbound on Young Rd at the intersection of Norton Rd and entered the intersection, striking unit #1 in the rear passenger side door. Due to the location of the damage on Unit #1, it was apparent that Unit #2 entered the intersection after Unit #1 was more than halfway into the intersection and had the right of way.
