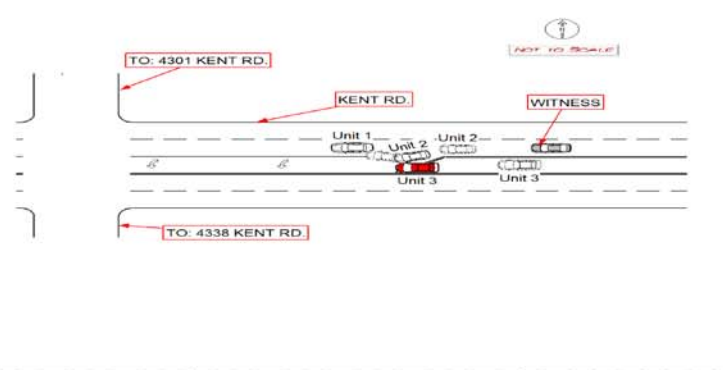
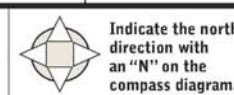

NARRATIVE
All three units were westbound on Kent Rd. Unit #1 was stopped in a line of traffic at the 4301 Kent Rd. red light. Unit #2 was behind unit #1 and entered the left turn lane. Unit #2 entered the turn lane when the lane markings indicated the turn lane began. Unit #3 had driven over the double-yellow line in order to pass stopped vehicles to enter the turn lane. Unit #3 disregarded the lane markings and improperly passed other vehicles. Unit #3 struck unit #2 as it entered the turn lane. The impact pushed unit #2 into unit #1. Unit #3 left the scene.

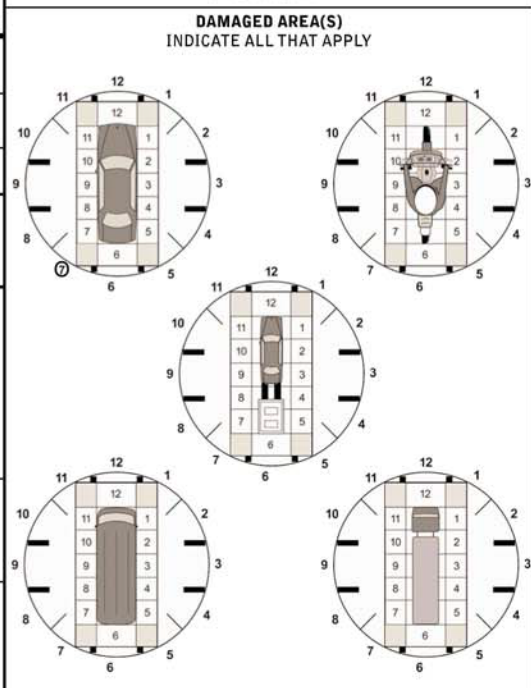

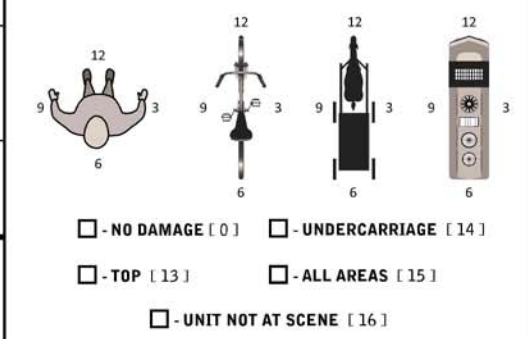

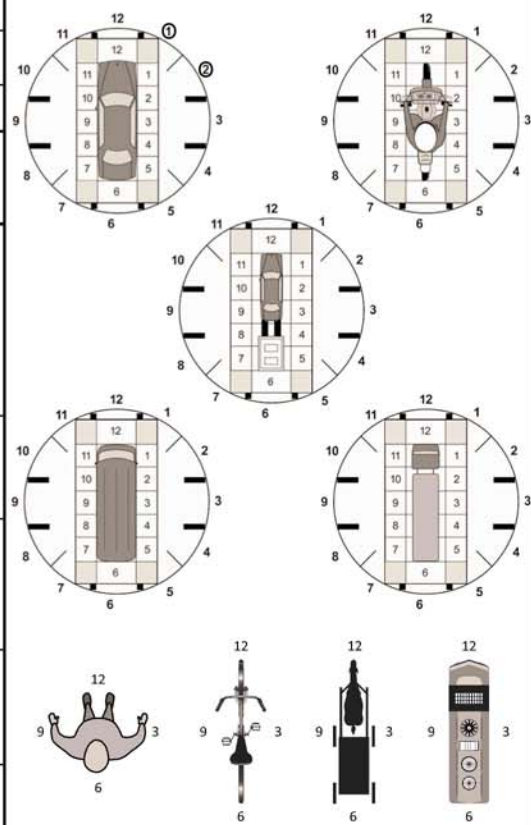
