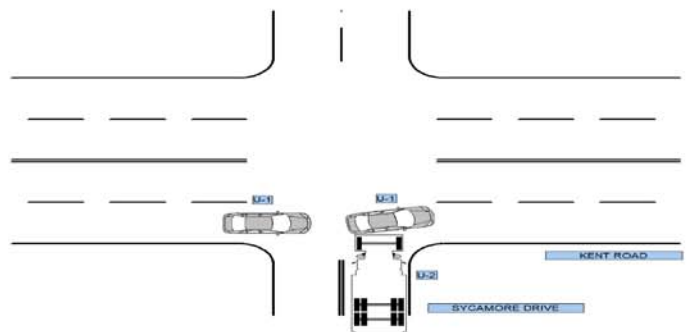
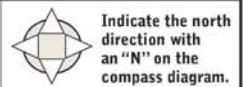

NARRATIVE

Unit 1 was e/b on Kent Road approaching Sycamore. He states that he was driving cautiously to make sure he didn't speed in the active school zone when he was struck in the passenger-side rear by Unit 2. Unit 2 was stopped on Sycamore at the red right waiting to enter the traffic lane to cross Kent Road n/b once his light turned green. According to Unit 2 and the witnesses, Unit 2's light turned green and after approximately two seconds he entered the traffic lane and the left corner of the dumpster on the front of the trash truck, struck the right side

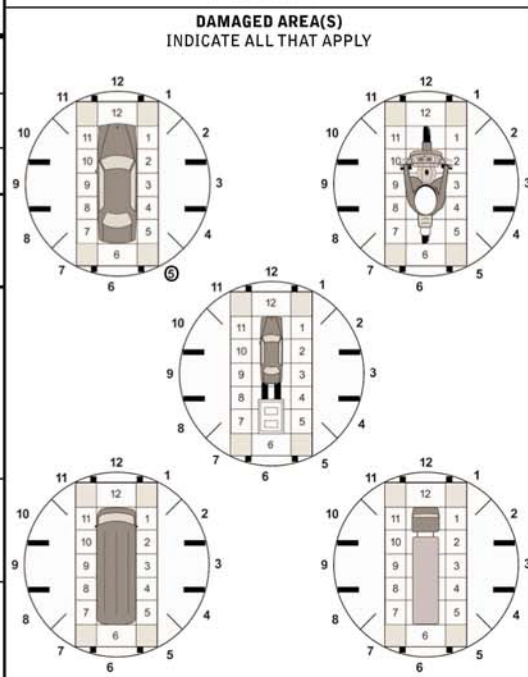

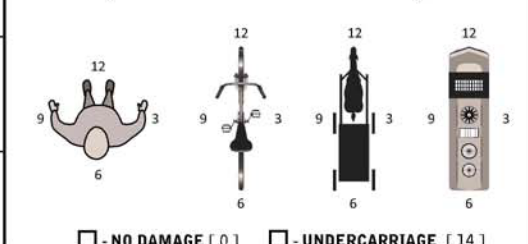

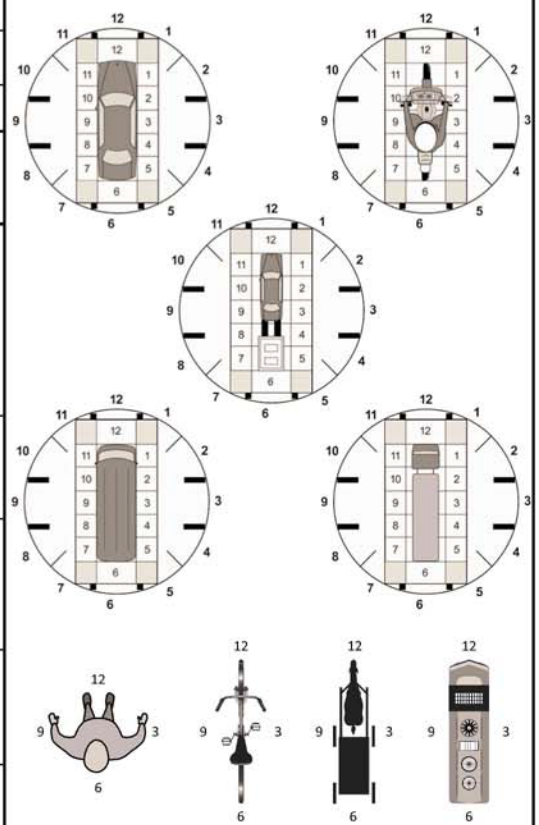
