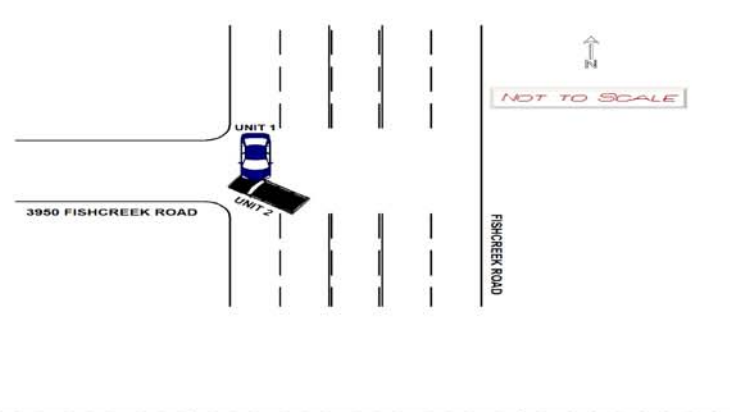
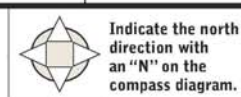

UNIT 1 WAS TRAVELING SOUTHBOUND ON FISHCREEK ROAD IN THE CURB LANE. UNIT 2 WAS TRAVELING NORTHBOUND ON FISHCREEK ROAD, AND ENTERED THE TURN LANE TO MAKE A LEFT (WESTBOUND) TURN INTO 3950 FISHCREEK ROAD. UNIT 2 FAILED TO YIELD ROW TO UNIT 1 AND WAS STRUCK BY UNIT 1.

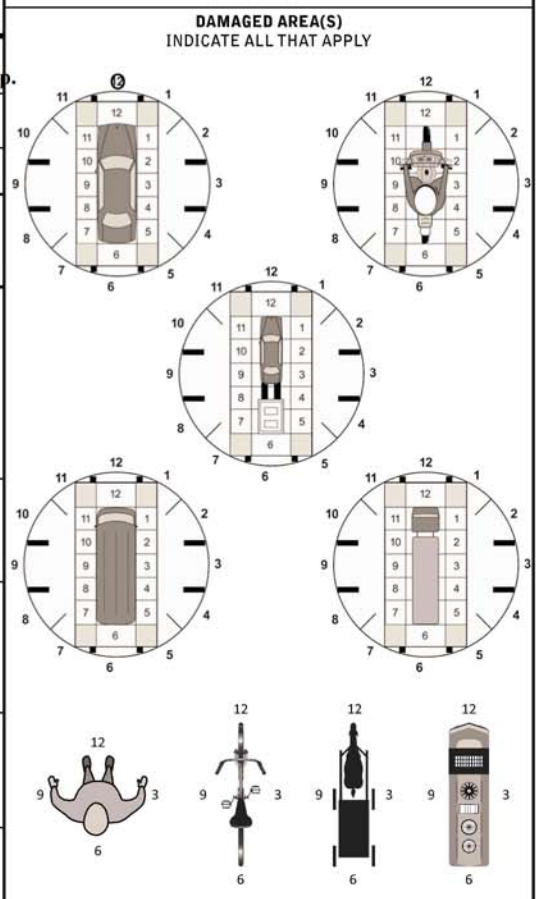

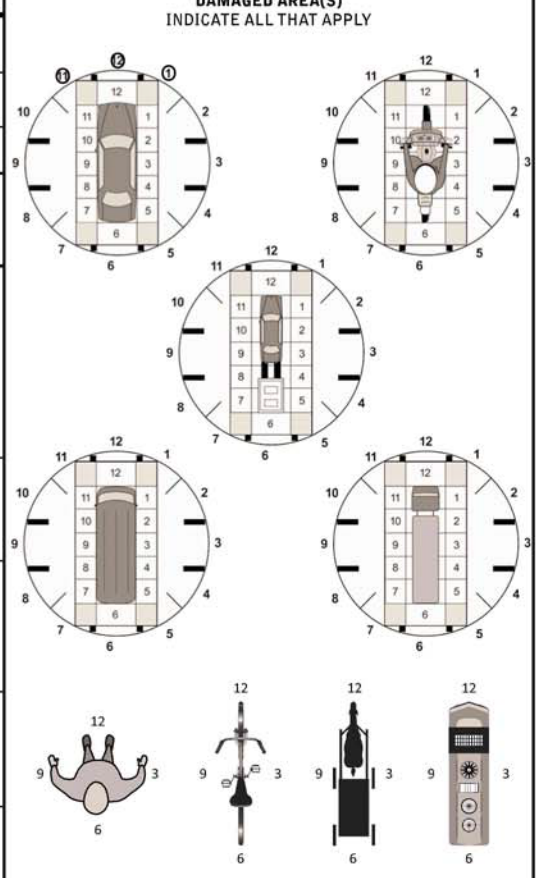
