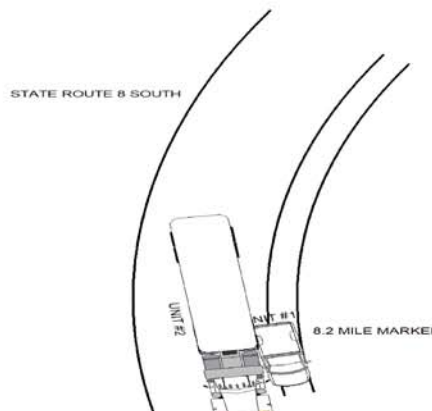
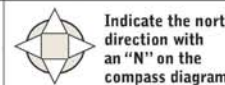

**UNIT #1 HAD RAN OUT OF GAS AND WAS DISABLED AND UNOCCUPIED ON STATE ROUTE 8 SOUTH NEAR THE 8.2 MILE MARKER. UNIT #2 WAS TRAVELING SOUTHBOUND ON STATE ROUTE 8 APPROACHING THE 8.2 MILE MARKER. UNIT #2 FAILED TO ASSURE CLEAR DISTANCE FROM UNIT #1. AS A RESULT, THE LEFT SIDE OF UNIT #2 STRUCK THE RIGHT SIDE OF UNIT #1. UNIT #1 THEN BECAME WEDGED IN BETWEEN UNIT #2 AND THE CONCRETE MEDIAN BARRIER.**
