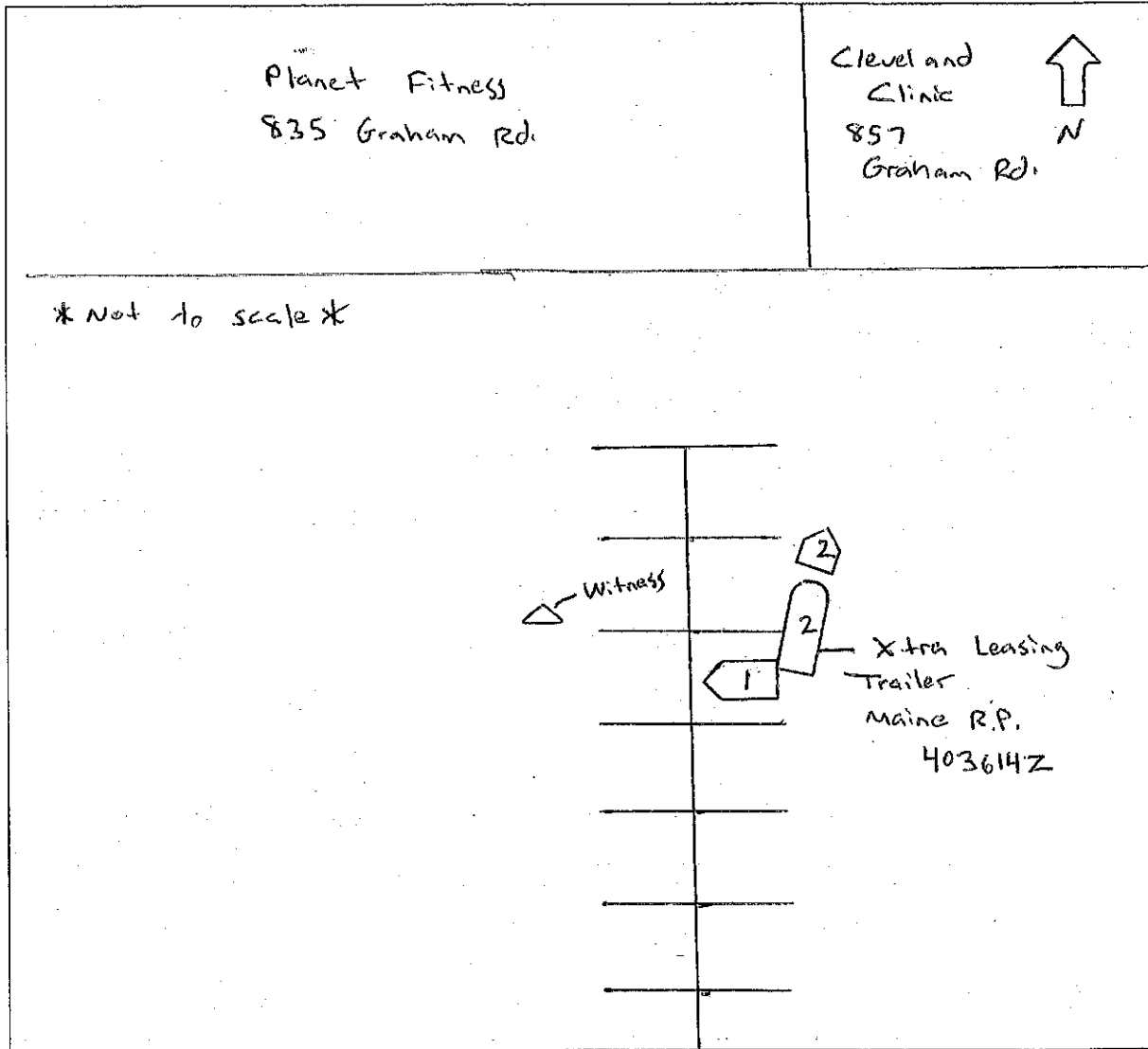

<p>I called Xtra Leasing and they advised the trailer GPS showed it was parked at Great Lakes Truck in Akron. I called Great Lakes and they advised the truck and trailer were still there and a male named Om Biswa dropped it off for service. The employee I spoke with went outside and took pictures of the truck and trailer. He emailed me the pictures and in one of them you can see a small amount of white paint transfer on the driver's side rear aluminum pillar of the trailer.</p> <p>I ran the name Om Biswa through LEADS and found a male that lived close by the crash scene that matched the description the witness gave. I went to his residence and he stated he was driving through the lot yesterday. He said he stopped for a few seconds to make sure he could make the turn and never noticed hitting anything.</p>
