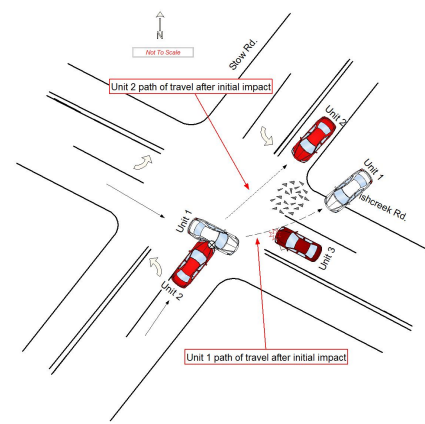
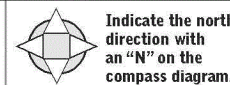

NARRATIVE

Unit 3 was at a red light stop on Fishcreek Rd. in the turning lane to turn onto Stow Rd. Unit 2 was traveling northbound on Stow Rd. approaching the intersection with Fishcreek Rd. Unit 1 was traveling southbound on Fishcreek Rd. and ran the red light at the intersection with Stow Rd. Unit 2 t-boned Unit 1 causing it to spin and strike Unit 3 before going into the ditch.

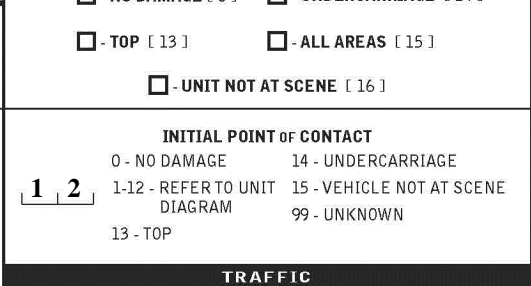
