**The accident was reported 1 day later by Driver #1. Officers were unable to get a hold of driver #2 for a statement. This report was taken from Driver #1's statement.**

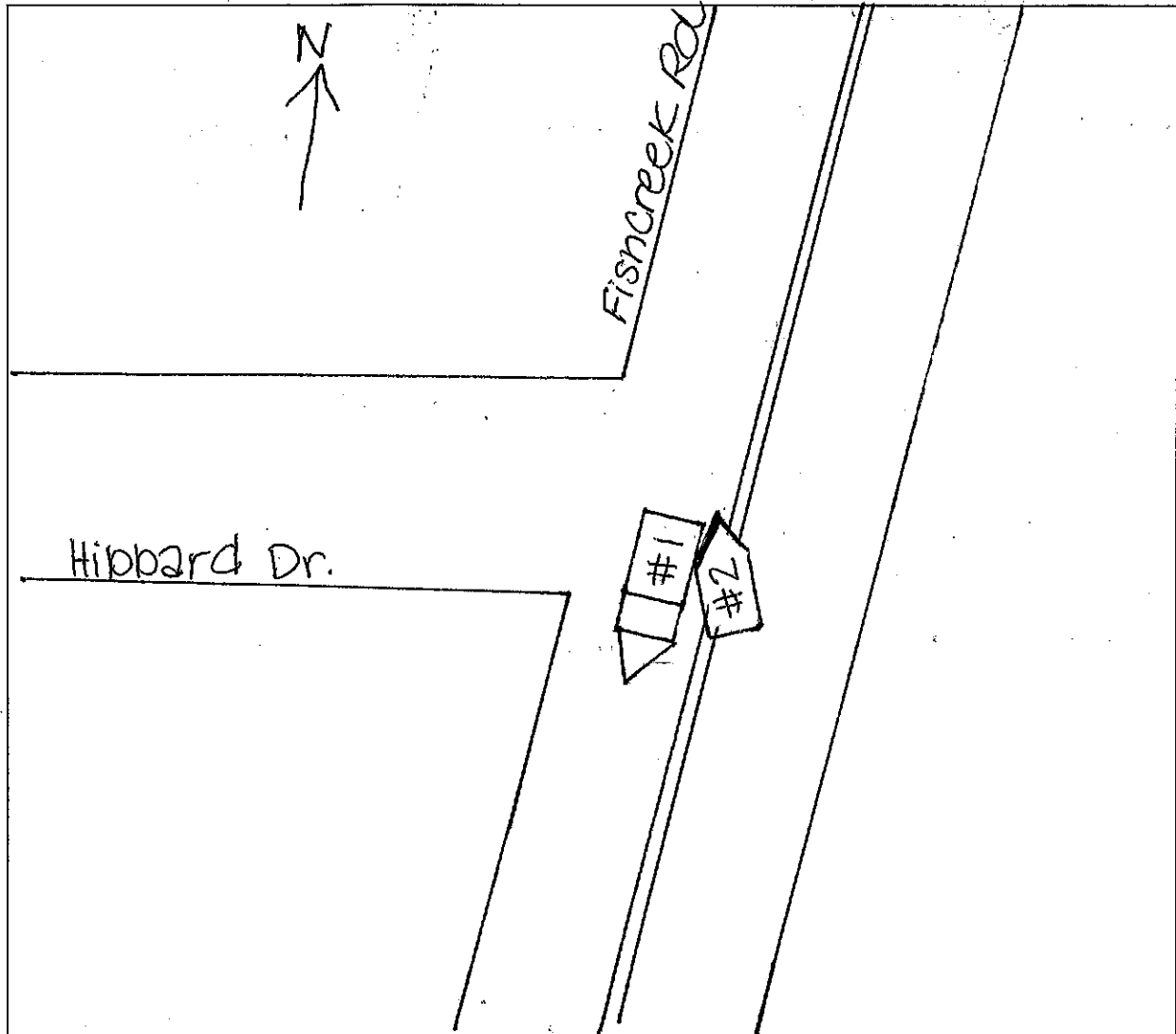
