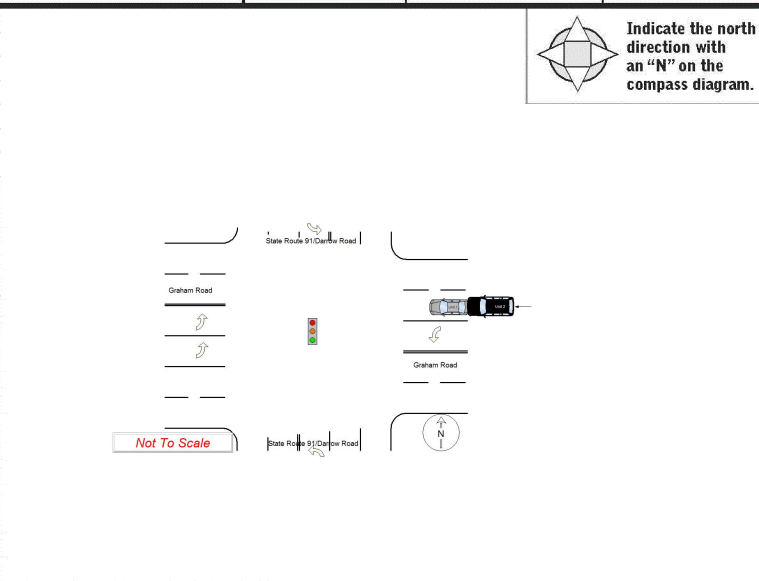

NARRATIVE
Unit 1 and Unit 2 were both westbound on Graham Road, stopped at the red traffic signal at State Route 91/Darrow Road. Unit 2 started prematurely, failed to maintain an assured clear distance ahead, and struck Unit 1 in the rear. *The Unit 1 passenger (owner of car) bumped her head on something in the vehicle at the time of the crash (possibly the opened visor), which caused minor discomfort, but declined treatment/EMS at the scene.

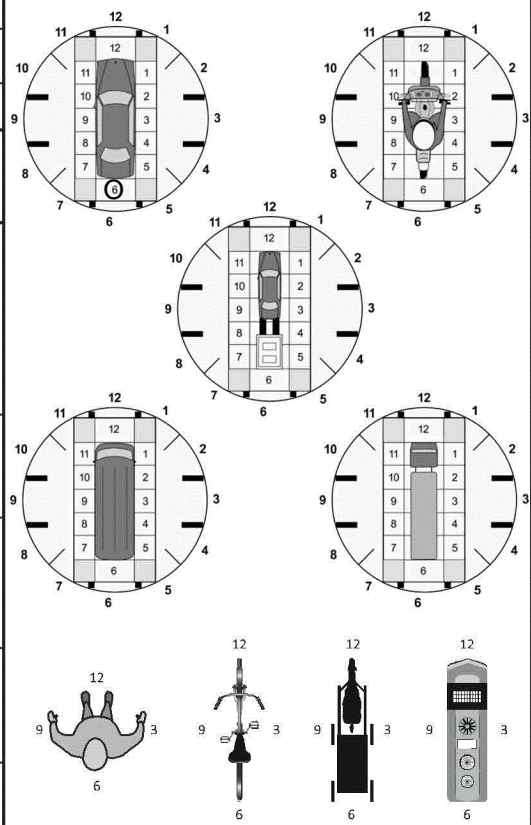

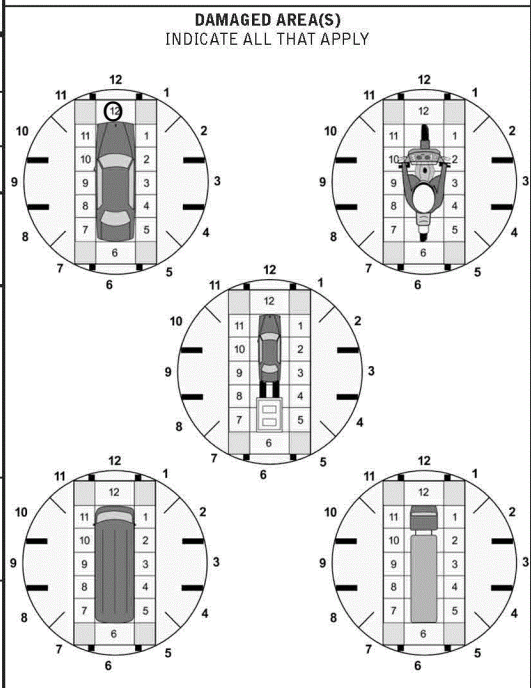

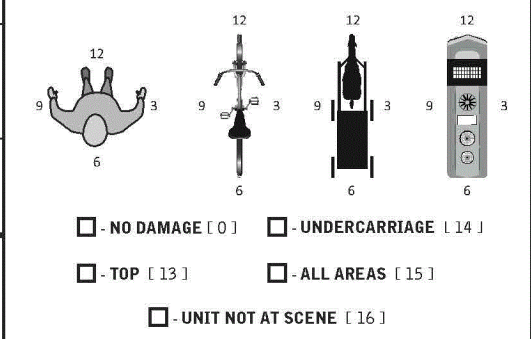
