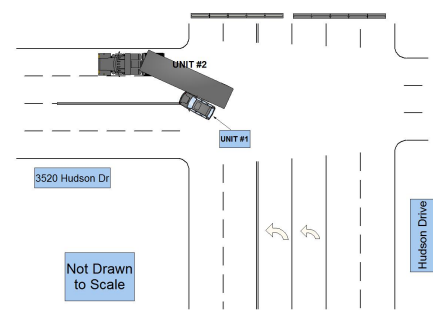

NARRATIVE

Both units were northbound on Hudson Dr and made a left turn westbound into the driveway of 3520 Hudson Dr. Unit #1 was in the inside left turn lane and unit #2 was in the outside left turn lane. The trailer of unit #2 and unit #1 collided at some point while both units were making their turns. The drivers of both units and the passenger in unit #1 gave conflicting statements as to the location of the units at the time of the collision. Due to this I wasn't able to determine who was at fault.

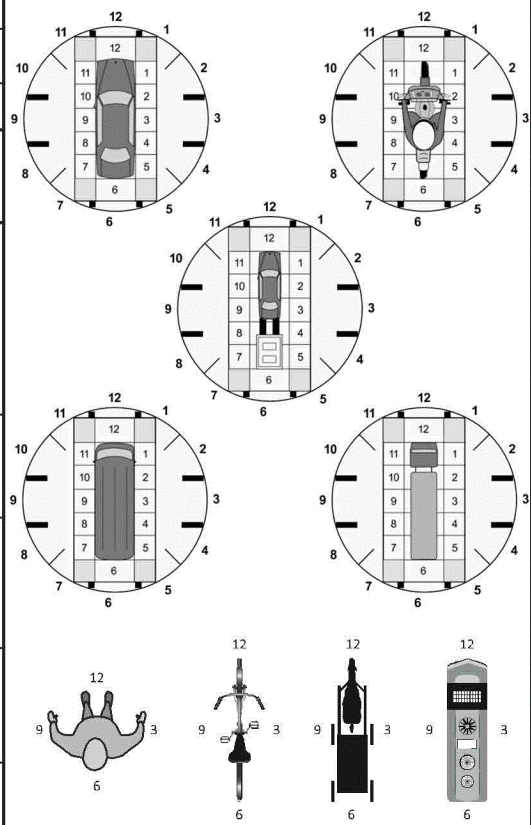
