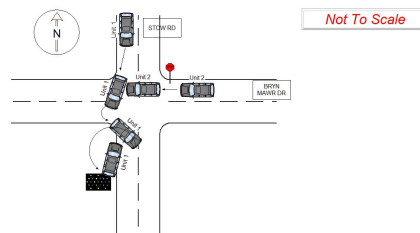
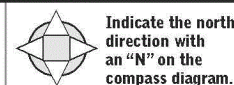

UNIT 1 DRIVER SWERVED TO ATTEMPT TO AVOID BEING STRUCK BY UNIT 2 BUT WAS UNSUCCESSFUL. UNIT 1 WAS SPUN AROUND, STRIKING A CONSTRUCTION SIGN AND COMING TO REST FACING NORTH IN THE SOUTHBOUND STOW RD LANE.**

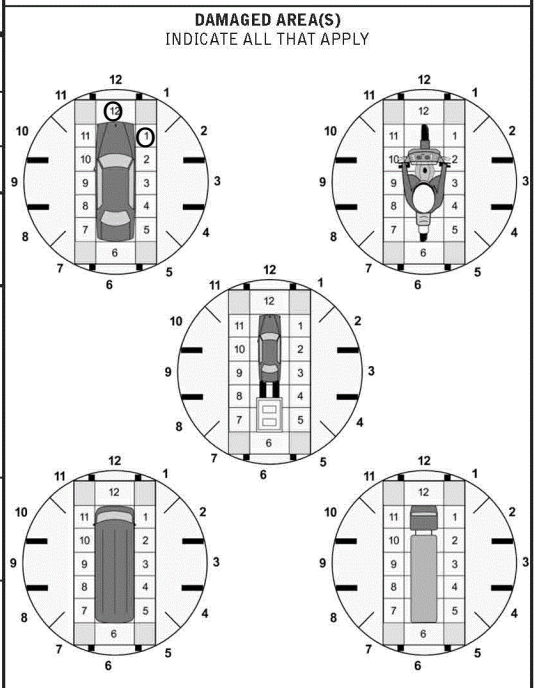

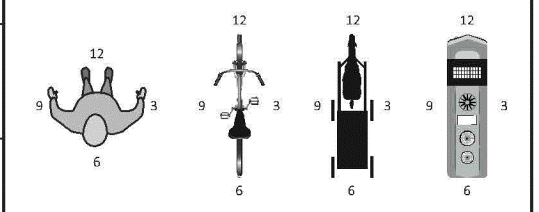

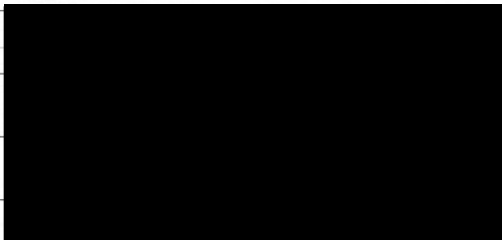
